Our year end results were 100% for all regulatory compliance and permit limits; 99.7% conformance to 'internal' limits for air permit compliance samples; and > 98% conformance to 'internal' limits for all wastewater treatment quality control samples.

As listed in Section E.4, Von Duprin LLC has implemented a new objective to monitor for % conformance to internal limits (in addition to permit limits). The objective for 2016 will be to maintain 100% permit and regulatory compliance in addition to exceeding 99% conformance to our internal limits. Our 2015 baseline is 100% permit and regulatory compliance and ~98% conformance to internal limits. (Internal limits are set at 50% of permit limits for wastewater effluent, +/- 0.75 permit limits for wastewater pH and 29 dynes/cm² for chrome plating surface tension vs a permit limit of 33.)
