- How to service programs better
- National outreach, education, referral program place where kids can ask for help and find resources.
- 14 programs in 25 counties programs may partner with other providers for various needs
- Voluntary program, youth initiated, runaway, kicked out of home
- Challenges to providing 24/7 services
  - o Placing unaccompanied youth with no DCS involvement
  - o A youth needing placement and the provider is full/at full capacity
  - o Youth voluntarily vs DCS/Probation placed and mingling the 2 populations
  - Delay in getting information on a youth
  - o Increase in severity of issues/needs
- Want to strengthen partnership with facilities
