BACKGROUND

Federal law requires that as a condition of eligibility for Temporary Assistance for Needy Families (TANF), each applicant or recipient of TANF shall assign to the State any rights to child support from any other person, which accrues during the period the family receives assistance.¹ The child support assignment shall not exceed the total amount of assistance paid to the family.² Therefore, as a condition of TANF eligibility, all TANF applicants and recipients shall assign their rights to accruing child support for children covered by the TANF grant during the assistance period to the Child Support Bureau (CSB).

POLICY

An application for TANF must contain a notice that if assistance is granted, the applicant assigns the applicant’s right to child support payments to the CSB, the State agency responsible for administering Title IV-D of the Social Security Act.³ In order for the TANF applicant to be eligible for assistance, if the applicant is entitled to child or spousal support, the applicant’s rights to present and pending child and spousal support payments are assigned to the CSB.⁴

The assignment of rights becomes effective when the applicant becomes eligible to receive TANF and is valid up to the amount of TANF assistance provided to the recipient that has not been reimbursed to the State.⁵ The assignment terminates, with respect to current child support, at the end of the benefit period and, with respect to accrued child support, when all assistance received by the recipient has been repaid.⁶

When there has been an assignment of rights, the Title IV-D Prosecutor’s Office is required to establish the paternity of a child for whom paternity has not yet been established. The Title IV-D Prosecutor’s Office is also required to secure a child support order from any person legally liable to support the child.⁷ The assignment of rights creates the obligation that any child support paid pursuant to a court order be disbursed, not to the custodial party, but to the State up to the amount of the TANF benefit.⁸
