- C. Chairman Rice entertained a motion to approve the minutes of the March 11, 2021 meeting.

Ms. Wojtowicz moved approval of the minutes; Mr. Goetz seconded the motion. Ms. Buskill called roll for a vote. Richard Rice, Mark Schroeder, Jean Wojtowicz, Ben Bochnowski, Don Goetz, and Tom Fite all voted yes. The minutes were approved 6-0.

#### D. DIRECTOR'S COMMENTS AND ACTIONS:

1. 2022 revenue and expense projections and initial fee discussion. (Michael Fracassa)

We have been reviewing our projected financials for FY 22 and we are currently projecting an increase in of \$800,000 in revenue over this year by because we are expecting an increase in revenue in depository assessments by \$800,000 because Indiana banks and credit unions significantly increased their assets in 2020. With this in mind we are considering the following:

 Because of the revenue increases we are considering reducing our fees back to 2019 levels on banks and credit unions which would be a 5% cut, and also not including PPP loans in the assessment. This would reduce revenue by \$320,000

- We are also looking to reduce volume fees back to their 2019 level of \$4 per \$100,000 which would reduce revenue by \$460,000, including \$130,000 reduction for depositories.
- With this reduction we will still have the ability to work through our current strategic
  planning and discuss what areas we need to strengthen going forward. We have had
  initial discussions about increasing our approved expenses and they have been
  favorable.

This is still tentative, and we are still working through the details of our strategic plan, but this reduction of \$780,000 and increase in expenses for FY 2022 would provide some relief to our institutions across the board, while also leaving DFI with enough revenue to implement some key strategic planning items we are considering.

Mortgage loan originator applicants must complete a criminal background check, a credit report, testing, and education as required by 750 IAC 9-3-2. The following one hundred sixteen mortgage loan originator applications are recommended for approval. Pursuant to 750 IAC 9-3-2(b), the department staff has reviewed the previously listed items and determined that the professional training and experience, financial responsibility, character, and fitness of each applicant is such as to warrant belief that the mortgage loan originator will operate honestly and fairly within the purposes of the article.
