Ms. Wojtowicz moved approval of the minutes; Mr. Goetz seconded the motion and the motion passed unanimously.

Ms. Buskill called roll for the vote. Mark Schroeder, Jean Wojtowicz, Ben Bochnowski, Don Goetz, and Tom Fite all voted yes. The minutes were approved 5-0.

Mr. Christopher Dietz, Depository Institutions Deputy Director, presented this application. Mr. Dietz informed the Members that Peoples Bank, Munster, Lake County, Indiana ("Peoples") and Royal Savings Bank, Chicago, Cook County, Illinois ("Royal") propose to effect a merger pursuant to IC 28-1-7 and 28-2-17-20.

Peoples and Royal entered into a merger agreement dated July 28, 2021. Peoples will survive the merger and Royal's main office will become a branch of Peoples.

Mr. Dietz reviewed and informed the Members that each of the statutory requirements of IC 28-1-7 and 28-2-17-20 had all been satisfactorily met.

Mr. Goetz asked about the tax ramifications of a transaction with a partial stock and partial cash payment to shareholders. A discussion ensued regarding IRS rules. Ms. Wojtowicz asked if Peoples has completed other acquisitions and Deputy Director Dietz provided an overview of the bank's past transactions.

A motion for approval of the application was made by Mr. Goetz and seconded by Ms. Wojtowicz. The application was unanimously approved.

Ms. Buskill called roll for the vote. Mark Schroeder, Jean Wojtowicz, , Don Goetz, and Tom Fite all voted yes. The application was approved 4-0

2. German American Bank, Jasper, Dubois County, Indiana

Mr. Schroeder left the meeting for this discussion due to the conflict of interest.

Mr. Christopher Dietz, Depository Institutions Deputy Director, presented this application. Mr. Dietz informed the Members that German America Bank, Jasper, Dubois County, Indiana ("GAB") and Citizens United Bank of Shelbyville, Shelbyville, Shelby County, Kentucky ("CUB") propose to effect a merger pursuant to IC 28-1-7 and 28-2-17-20.

GAB and CUB entered into a merger agreement dated September 20, 2021. GAB will survive the merger and Royal's main office will become a branch of GAB.

Mr. Dietz reviewed and informed the Members that each of the statutory requirements of IC 28-1-7 and 28-2-17-20 had all been satisfactorily met.

A motion for approval of the application was made by Mr. Goetz and seconded by Mr. Bochnowski. The application was unanimously approved.

Ms. Buskill called roll for the vote. Jean Wojtowicz, Don Goetz, Ben Bochnowski, and Tom Fite all voted yes. The application was approved 4-0.

E. DIRECTOR'S COMMENTS AND ACTIONS:

1. Delegation of Authority

Nicole Buskill presented a revised Delegation of Authority, which grants the Director the ability to further delegate the approval of certain MLO applications to consumer credit staff. The approval is only for MLO applications that are seen as routine applications that meet all licensing criteria and do not have any matters that disqualify the MLO from licensure. Buskill stated that the reason for the change is that the consumer credit licensing staff is seeing a significant increase in the number of mortgage loan originator ("MLO") application and that delegating the authority to approve MLO applications directly to the licensing staff will save significant time without increasing risk.

The updated Delegation of Authority also added Civil Proceeding Advance Payments to the list of entity applications and change of control applications that the Director may approve. The third change is to make it clear that the Director may amend consumer credit forms as necessary.

Jean Wojtowicz motioned to approve the Delegated Authority Order, and Don Goetz seconded the motion.

Ms. Buskill called roll for the vote to approve the Delegated Authority Order. Mark Schroeder, Jean Wojtowicz, Ben Bochnowski, Don Goetz, and Tom Fite all voted yes. The Order was approved 5-0.

2. Legislative Update

Nicole Buskill presented the details of the annual DFI bill which includes 7 proposals. They are:

1. Annual federal law reference update;
2. Credit Union bond coverage update;
3. Permit a federal savings association to convert to an Indiana savings association;
4. First lien mortgage act change of control notice requirement;
5. Rental purchase payment method modernization, technical correction, and refund requirement;
6. Uniform consumer credit code amendments and conforming changes across regulated entities; and
7. Money transmitter act amendments.

Staff has asked Senator Bassler to author the bill again this year and the bill is being prepared for filing.

3. Director Fite advised the Members of actions taken pursuant to Delegated Authority.
