## **MEETING DETAILS**

### 1. Call to Order

Chairman Murua called the meeting to order at 1:01pm.

## 4. Review of Code Change Proposals and Fiscal Impact

- a. 234 101.2 Scope Proponent requested that proposal be tabled.
- b. 333 Definitions Construction Documents Approved.

- c. 193 Definitions Fire Apparatus Access Road Mr. Cook notes that if the building is sprinklered then the requirement goes away, but with the new proposal this may not be the case. Discussion was had about whether adding police or EMS was appropriate for the amendment. Approved.
- d. 283 310.2 Prohibited Areas Tabled after discussion. Proponent will re-write.
- e. 284 310.3 "No Smoking" Signs Tabled with 310.2.
- f. 323 315.2 Permits Required Approved without discussion.
- g. 341 316.6.2 Outdoor Storage Ms. Wakefield does not believe that the fire chief has the authority to allow parking on an easement, as easements are generally private property designated for utility use and parking equipment on such would create potential conflicts. Tabled.
- h. 326 319.2.2 Occupancies Approved without discussion.
- i. 327 319.3.1 Permits Required Approved without discussion.
- j. **328 319.3.10 Technical Assistance –** Ms. Wakefield suggested modifying the proposal to reference the Indiana Code and not the GAR. **Tabled** after discussion, as the complexity involved can be quite technical and the wording may need to be altered.
- k. 329 319.3.11 Performance-Based Design Alternative Mr. Burgauer notes that the substantive proposal allows for non-compliance with other requirements in the section. Tabled while proponent reworks motion.
