- vi. **24-07-34 University of Indianapolis Classroom Door Locks (Indianapolis)** – UI wants to use a lock system to barricade doors during active shooter event. Variance approved last year for same devices in middle school. IFD has concerns about the devices, which require special training and knowledge to use rather than a key to unlock it. IFD requests that if the variance is approved, special box that first responders have access to put at IFD specified locations by IFD, it only applies to this particular device and require annual training. Chief of Police UI supports variance. Chief Frost expressed concern with the device use. Chief Cross spoke toward similar devices used in Noblesville schools, suggested adding mandate for disciplinary policy for misuse. Commissioner Patarino wishes to note that Commission does not endorse or opine on the efficacy of this particular item, only allowing for use and mandating uniformity throughout the university campus.

Motion: Approve with conditions: Annual training with first responders, all students, faculty, and staff; special boxes for release mechanisms placed at visible locations coordinated with first responders; only this device make and model used throughout campus; university must develop and implement disciplinary policy for unauthorized use.
