To Whom It May Concern:

Indiana Task Force One is one of 28 FEMA Urban Search and Rescue Task Forces in the United States. The team is comprised of firefighters, law enforcement officers, Medical personnel and civilians from throughout the State of Indiana. The team exists to meet its stated objective of rescuing trapped civilians from the effects of natural and man-made disasters and austere environments.

INTF-1 stands first as a local USAR asset serving Central Indiana, secondly as a State Wide asset, and third as a Federal asset. As a local and State response partner, INTF-1 strongly believes in being a leader in the training, certification, and continuing education of its members. To that end, we have been training and certifying our members using the IDHS certification system for Technical Rescue disciplines and following the NFPA 1670 Standard on Operations and Training for Technical Search and Rescue Incidents since 2005. Although the team is not required by FEMA to certify its members using the IDHS system, the team feels it is important to lead by example in this area.

INTF-1 has scheduled a Rescue Specialist Course to train and certify 25 members in 2018. Participants in the course will be trained and certified to the Technician level in Vehicle/Machinery Rescue, Rope Rescue, Swift Water Rescue, Confined Space Rescue, Trench Rescue, and Structural Collapse Rescue. The training is scheduled to begin in March and will conclude in October. Please see the schedule below:

This schedule represents a significant investment from both INTF-1 and the participating agencies. In order to ensure all members have the opportunity to receive certification to the Technician level for their participation in the course, INTF-1 is requesting a Variance be granted by the board for course participants to take course exams for Operations and Technician concurrently.

Additionally, INTF-1 requests a variance from the board to allow members to participate in written examinations and receive certification prior to holding an in-hand certification for a prerequisite course.

The board requirement for members to hold an in-hand certificate for an Operations level course prior to participating in a Technician level course, poses the real possibility to have an interruption to the certification of INTF-1 members. As well as, adding a significant financial impact to the costs associated with course delivery. We appreciate your consideration of this request and your assistance in maintaining the capabilities of INTF-1.
