## Message from the Administrator

As State Fire Marshal Joel Thacker and I travel to volunteer fire departments across the state, one issue rises above all others: How do we attract volunteers willing to join Indiana's volunteer fire service?

External time commitments, family and full-time jobs, as well as the time commitments to train volunteers, often stand in the way or hinder those wanting to join the fire service. One trend that is emerging around the country is making training more accessible by offering online training opportunities and reducing initial training requirements in efforts to increase recruitment of new volunteers.

Both of these topics are currently being worked on by the Fire and Public Safety Academy. Partnering with the Indiana Volunteer Firefighters Association (IVFA), we will develop a model of training that works for Indiana's volunteer fire service.

In the next few months, there will be more information on how to improve access to more online training opportunities as well as a new training model to reduce the initial training requirement to join a volunteer fire department.

### Jasper Fire Department (Dubois County)



The city of Jasper is located 120 miles southwest of Indianapolis,  
along IN-56 in Dubois County. Established in 1896, this all-  
volunteer department and its 38 members provide fire protection  
and medical response for the city of Jasper and Bainbridge  
Township, totaling over 32 square miles.

Fire Chief Kenny Hochgesang oversees the day-to-day  
operations of the department. Chief Hochgesang also serves as  
the city's code enforcement officer.
