## Message from the Director

I want to discuss solar and green energy home fire suppression this month. Did you know the Underwriters Laboratory (UL) Fire Safety Research Institute (FSRI) has added a firefighter safety training course on "Photovoltaic Systems?" This is now available at: <a href="https://training.fsri.org/course/003-photovoltaic-systems">https://training.fsri.org/course/003-photovoltaic-systems</a>. In this course, you will examine the hazards associated with photovoltaic systems and essential safety considerations related to suppression, ventilation and overhaul operations on the fireground.

Indiana State Fire Marshal Thacker and I have taken this course. I found that it provides valuable information that firefighters should know before fire suppression efforts on solar and green energy homes. This course took me less than one hour from start to finish, and there is a test after the training is complete. One of the great things about this course is this training is free and online. However, you will need to create a free account to take the training. Once you pass the test, you can download your certification. ## **Rockville-Adams Township Fire Department**



Rockville is located 75 miles west of Indianapolis along US-36 in central Parke County. The Rockville-Adams Township fire department was established in 1871 as the Rockville Fire Company. It was reorganized in 1906 by Chief Lewis Wallace Brown at the request of the Town Council. Fire Chief Jim Veach leads Rockville-Adams Fire, and the fire department has 17 members, with one member on duty 24 hours a day, seven days a week. Assistant Chief Josh Sorrels is the fire department's chief inspector and building commissioner, Monday through Friday. The Rockville-Adams Township Fire Department provides fire and rescue protection to 80 square miles, including Rockville and Adams Township.
