On behalf of the Fire Prevention and Building Safety Commission (the Commission) and its IDHS staff, I have received your message below, requesting that Christina Collester be considered for appointment as the code consultant representative on the Commission's code update exploratory committee. Robin Nicoson has resigned from his position as the chairman of the Commission, and now Michael Popich, vice chairman of the Commission, will assume the duties of the chairman of the Commission until Governor Holcomb officially appoints a new chairman. I've included Vice Chairman Popich on this message, and I've also copied Philip Gordon, Deputy Attorney General and Legal Counsel to the Commission. Our IDHS commission staff will review requests for appointment to exploratory committee and consult with Vice Chairman Popich over the next few weeks, before we propose recommendations to the Commission, likely at the Commission's next scheduled meeting in January.
