## County Cyber Conversations

The Indiana Office of Technology and the IN-ISAC are [joining local leaders](#) to discuss HEA 1169 (2021) reporting requirements, the IN.gov Program and prevention methods for a cyberthreat and attack. It's important in today's tech-reliant



One line of preparedness that gets overlooked is cyber preparedness. It can be easy to think getting hacked or compromised could never happen to us or here. Still, according to the [Identity Theft Resource Center \(ITRC\)](#), in 2021, there were more data compromises reported in the U.S. than in any year since the first State Data Breach Notification Law became effective in 2003. That is 68% higher than 2020 reports. With that in mind, here are some tips to keep yourself, your family and your organizations safe from cyberattacks.

- **Implement multi-factor authentication:** This can make you 99% less likely to get hacked. Enable multi-factor authentication on your email, social media, online shopping, financial services account, etc.
- **Update your software:** Update the operating system on your mobile phones, tablets and laptops. Also update your applications on all your devices. Turning on automatic updates can make it easier to stay safe.
- **Think before you click.** More than 90% of successful cyberattacks start with phishing emails. A phishing scheme is when a link or webpage looks legitimate, but it's a trick designed to have you reveal your sensitive information. If it's a link you don't recognize, trust your instincts, don't click the link and report the email.

One other great tool is Cybersecurity and Infrastructure Security Agency's (CISA) **Shields Up** program. It gives guidance for all organizations to protect against malicious cyber activity.

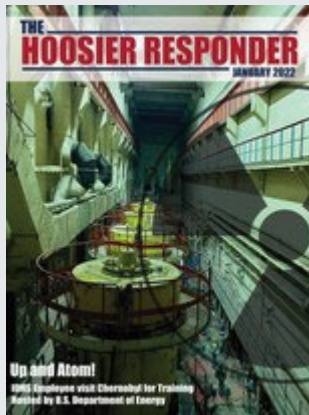

**Deadline** to Request FEMA Exercise Support is **April 1**, and decisions will be sent by **May 6, 2022**. To submit a support request, please email the completed support request form and required supporting documentation to the [National Exercise Division](#) by the deadline. The support request form and detailed instructions on how to submit your support request package are available on the [NEP website](#).

For jurisdictions not ready to submit a request at this time, the NEP will hold additional exercise support rounds in fall 2022 and spring 2023. If you have any questions, please contact the [National Exercise Division](#).

On **July 1, 2022** two things will go into effect:

- **RPA deadline.** Any RPAs (Request for Public Assistance) forms will not be accepted. This form is only for those who have yet to be declared an eligible applicant by FEMA and are not actively submitting projects into the Grant Portal.
  - **The 100% Federal Cost Share** will end on July 1, 2022. The cost share will then switch to a 90/10. FEMA will reimburse 90% of all PA eligible project costs and the applicant will be responsible for the 10% of those costs.

### IDHS/IDEM collecting PFAS foam from Indiana fire agencies

The Indiana Department of Homeland Security (IDHS) and the Indiana Department of Environmental Management (IDEM) has launched a program to collect Per- and Polyfluoroalkyl (PFAS) foam from Indiana fire agencies.

The State will remove and properly dispose of PFAS material from any agency that requests it. **This is a free service with no additional requirements for fire agencies.**

## Grants Updates

**[The FFY 2022 Nonprofit Security Grant Program](#)** and **[FFY 2022 State Homeland Security Program grant](#)** will open soon. The latest information from FEMA indicates that the federal Notice of Funding Opportunity will be released **mid-May**. We are also anticipating that the window for applications will be very short as the State is expecting a limited timeframe to submit the State application.

You are encouraged [to sign up for grant updates](#) so that you will get notified when IDHS announces Indiana's due date and puts all of the 2022 NSGP information up the website.

[Last year's application](#) and information is still on the IDHS website and can provide guidance on the application process and forms that will be required.

On April 4, the federal government will stop using the DUNS number to uniquely identify entities and instead will turn to the Unique Entity Identifier (UEI) created in SAM.gov. This change allows the government to streamline the entity identification and validation process, making it easier for entities to do business with the federal government.

To receive federal funding, an entity must have an active UEI number. Any grants awarded from IDHS will now require an active UEI number. Please prepare accordingly to have an active UEI prior to applying for grants.

Current SAM.gov registrants already have been assigned their UEI and can view it in SAM.gov. This includes inactive registrations. The UEI can be found below the DUNS Number on your entity registration record. Remember, you must be signed in to your SAM.gov account to view entity records.

IDHS recommends that applicants review the [SAM.gov database](#) to ensure their UEI number is updated and active.
