

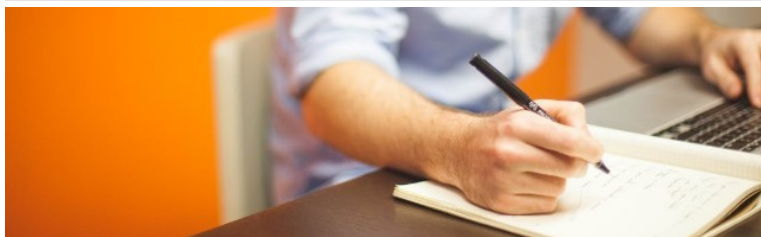

- Nomination process overview;
- Benefits of nominating an exercise to the NEP;
- Exercise support within a COVID-19 environment and best practices for virtual exercises; and
- Approved 2021–2022 Principals' Strategic Priorities (PSP).

Vaccine Survey Still Open

The [COVID-19 Critical Infrastructure Vaccine Survey](#) is still collecting data. Please consider reaching out to critical infrastructure and industries and encourage them to provide their information.

The information is being viewed by IDHS, Department of Health and Family Social Services Administration to inform decision-making.

The National Flood Insurance Workshop is going virtual this year, with three different opportunities to attend each module. Community officials (i.e., floodplain administrators, zoning administrators, surveyors, planners, building officials, commissioners, council members, or mayors) who are new, or just want a refresher, are encouraged to attend.

New Administrators Part I covers general NFIP, mapping information, fundamental duties of the Floodplain Administrator, building protection standards, the Indiana Flood Control Act, and the Indiana Lake Preservation Act. Sessions are two hours, and will be available on Feb. 23, 24 and 25. [Register here.](#)

New Administrators Part II covers post-flood responsibilities, increased cost of compliance, variances in the special flood hazard area, and mitigation measures. Sessions are two hours, and will be available March 2, 3 and 4. [Register here.](#)

New Administrators Part III covers the Indiana Floodplain Information Portal (INFIP), Division of Water's Online Research Center (DoWORC), mapping examples, permitting examples, and additional resources for local officials. Sessions are two hours, and will be available on March 9, 10 and 11. [Register here.](#)

The workshops are free, but registration is required. The workshops are eligible for Continuing Education Credits for Certified Floodplain Managers (CFMs).
