Response and Recovery Updates

The Indiana Department of Health has [PPE and supplies available](#). County EMAs are welcome to request resources through the portal. All requests should be ordered through Langham Logistics. Please refer to the guidance document provided

On **July 1, 2022** two things will go into effect:

- **RPA deadline.** Any RPAs (Request for Public Assistance) forms will not be accepted. This form is only for those who have yet to be declared an eligible applicant by FEMA and are not actively submitting projects into the Grant Portal.
- **The 100% Federal Cost Share** will end on July 1, 2022. The cost share will then switch to a 90/10. FEMA will reimburse 90% of all PA eligible project costs and the applicant will be responsible for 10% of those costs.

Planning Updates

Special Event Assessment Rating (SEAR) Reporting – Federal DHS and IDHS are requesting County EMAs to update their county SEAR board in WebEOC for Indiana events planned for Dec. 1, 2022 and Nov. 30, 2023. This year's deadline is Friday, Aug. 26, 2022. The SEAR board has been developed by the IDHS IT team to make it easier to duplicate an event and change the dates along with scrolling through pages. This also allows EMAs to update the National Weather Service on if they would like NWS assistance for a particular event (or each event) and then save the event information. Grants Updates

In FY2020, a tier-based system was implemented to promote equity and ensure sustainability in the distribution of EMPG funding for county EMA personnel. Last year, IDHS enhanced Indiana's EMPG funding strategy by reallocating underutilized funds to increase the support provided to counties with a history of strong EMPG utilization. This system will continue for the FY2022 cycle for EMPG, which will open for applications later this year.

Notification will be distributed to all county EMAs before the application period begins.

County EMAs will continue to be able to request, based on their funding tiers, reimbursement funding for annual salary expenditures for up to three (3) full-time positions. As in previous years, the funding awarded also may not exceed 50 percent of the total annual salary for those positions.

Please note: Reimbursement funding provided through FY2022 EMPG is for EMA personnel salaries paid from January 1, 2022, through December 31, 2022.

Funding tiers are now based on 2020 Census data. Only four counties will see a change in their funding eligibility as a result of the 2020 Census, and each will be notified by IDHS prior to the opening of the FY2022 EMPG application period. Below are the population thresholds and their associated funding tiers:

- **Less than 25,000:** \$18,000
- **25,000-75,000:** \$30,000
- **75,000-200,000:** \$55,000
- **200,000 or greater:** \$75,000

The FY2023 Hazardous Materials Emergency Preparedness (HMEP) grant application will open in IntelliGrants on Wednesday **June 15, 2022**, and will close on **July 15, 2022 at 4:30pm (EST)**. Please read the Notice of Funding Opportunity (NOFO) carefully as there has been some changes, including an increase in the cap of funding per project to \$20,000. Applicants may submit one project per application and can submit multiple applications to consider for funding. For FY22 salary reimbursement, IDHS is reducing the number of HSEEP exercises from three (3) exercises to one (1) exercise required for salary reimbursement. Current policy and guidance documents are being updated to reflect this change. The training course requirement will stay the same.
