COVID-19 Update

Vaccine Eligibility

The Department of Health has announced eligibility for Indiana residents 50 and over. Individuals with specific comorbidities such as current or recent cancer treatment, sickle cell disease, dialysis patients, Down syndrome or a solid organ transplant should have heard from their health provider with more information on scheduling their vaccine.

Public Assistance Program


