

The IDHS Planning Section has been very busy assisting with the Afghan evacuees temporarily housed at Camp Atterbury mission. Planners are working in the SEOC providing situation reports for the armory donation collection sites and also working alongside of our Recovery staff at Camp Atterbury. Planners are supporting our volunteer organizations and our state and federal partners in managing ESF-14 and Private-Public Partnerships (PPP) in obtaining donations and volunteers. Furthermore, staff have been participating in base planning efforts and capturing the updates for our own state plans.
