CALL TO ORDER AND ROLL CALL

Meeting called to order at 10:03am by Vice Chairman Charles Valentine. Ms. Candice Hilton called roll and announced quorum.

ADOPTION OF MINUTES

a. Adoption of minutes from the April 29, 2016 session. . Commissioner Hoggatt commented that he is listed as present at the April meeting but he was not present.

A motion was made by Commissioner Mackey to accept the minutes from the April meeting. The motion was seconded by Commissioner Champion. The motion passed with the correction added.

INDIANA DEPARTMENT OF HEALTH

- a. Trauma Registry (see attachment #1) Mrs. Katie Hokanson announced that this is the last Narcan report that the Health Department will provide for the Commission because as of July 1st EMS providers are responsible for reporting the use of Narcan.
- b. "In the Process" applications Mrs. Hokanson also stated that there are no new ACS in verification applications to report on however there were a couple of hospitals that the Trauma Care Committee had to discuss. The hospitals under discussion were St. Elizabeth East, Community Hospital of Anderson, and Good Samaritan have hit the two year mark all three hospitals have been granted an extension and will be required to submit a one year report. The reports will be reviewed at the next Trauma Care Committee meeting. St. Elizabeth East had their site visits in December and had a number of type II deficiencies but the Trauma Care Committee reviewed the deficiencies and decided that they are not putting patients at risk so they are still able to receive patients.

Mrs. Hokanson reported that the Medical Directors conference is scheduled for August 26th at this time registration is not opened at this time but hope to have it opened in the next couple of weeks. The Labor of Love conference will be held on October 17th it was not previously opened to First Responders but this year it will be. Ms. Gretchen Martin announced that here will be a DOSE – Direct on Scene Education program will be at the summit and will be presented by Captain Carroll. The program is a train the trainer program. Captain Carroll will also be at the Indiana Emergency Responder Conference. Director Mike Garvey reminded providers to get run reports turned into the hospitals within 24 hours of the patient drop off.

EMS FOR CHILDREN (EMSC)

There is no report at this meeting. Ms. Margo Knefelkamp introduced herself to the Commission and stated that there would like to meet all of them.

TECHNICAL ADVISORY COMMITTEE (TAC)

a. Report— Chairman of the Technical Advisory Committee Leon Bell reported that the Technical Advisory Committee had their first virtual meeting. Chairman Bell stated that the TAC reviewed the Trauma Transport Rule and are recommending that the Commission accept the Trauma Transport Rule as written.

A motion was made by Commissioner Mackey to accept the TACs recommendation. The motion was seconded by Commissioner Lockard. Discussion followed. The vote was taken with one opposing the motion and the majority voting to pass the motion. The motion passed.

Education for the public and providers about the trauma system was discussed. Director Garvey commented that IDHS will work with Mrs. Hokanson to bring back a recommended list of people for a work group to create a program.

Chairman Bell stated that the TAC had a lot of discussion regarding the Stemi protocol. The TAC is asking that the Chairman of the Commission needs to appoint a group to discuss the stemi protocol. Vice Chariman Valentine stated that they will put a group together and report at the next meeting.

INDIANA EMERGENCY MEDICAL SERVICES ASSOCIATION (IEMSA)

Mr. Faril Ward the current President of the IEMSA reported out. Mr. Ward stated that the licenses plate sales are going better than expected. The association voted to dedicate 50% of the license plate sales will go to the EMS Memorial. The other fund raising effort is the challenge coin they are \$20.00 each. They will sell a batch of 10 for \$150.00. So far 491 have been sold. The third fund raising effort is that they have started a GO Fund me account and it had already received some donations. IEMSA is working on their conference hotel rooms are filling up fast so if you are going to go you need to get registered. Registration is at IndianaEMSconference.com. IEMSA is also in the middle of a membership drive. Membership to IEMSA also gives you a membership to the National Association of EMTS. Indiana is number two in memberships to the National Association of EMTS. Nathan Metz will be the new President of IEMSA after June 30th, Faril Ward will be the past president, Justin Farrell will be the new treasurer, Region 2 representative will be Robert Miller, Nathan will pick his own Vice present at their next meeting, Region 1 representative is Gary Miller, Region 3 is Cindy Cowen and Colby Reel, Region 5 Mike Ross was reelected, Region 4 was not up for election at this time, Secretary Garrett He retained his position. Mr. Ward expressed IEMSA's support of the Commission moving to the National Registry.

EMS EDUCATION WORKING GROUP

Mr. Kraig Kinney reported that the work group had been looking at how to stream line the Indiana specific pieces such as the POST. The group has been working on getting something put together. The group has also made some updated to the Training manual that is ready for the TAC to review at their next meeting. The Education working groups next meeting will be held at the Indiana Emergency Responder Conference.

PERSONNEL WAIVER REQUESTS

The following requested a waiver of Rule 4. Certification of Emergency Medical Technicians 836 IAC 4-4-1 General certification provisions Authority: IC 16-31-2-7 Affected: IC 16-31-3 Sec. 1 which reads (a) Applicants for original certification as an emergency medical technician shall meet the following requirements: (1) Be a minimum of eighteen (18) years of age. (2) Successfully complete the Indiana basic emergency medical technician training course as approved by the commission and administered by a certified training institution. (3) Pass the emergency medical technician written and practical skills examinations as set forth and approved by the commission. (b) The applicant shall apply for certification on forms provided by the agency postmarked within one (1) year of the date that the course was concluded as shown on the course report. Mr. Edmond is requesting additional time to complete his practical skills exam. Mr. Edmonds course ended on May 11, 2015. He has been unable to complete the testing because of family emergencies and could not find an exam in time. He has completed his written exam and POST exam. Staff recommends: 60 days to complete practical skills exam. There are 3 practical skills exams in Lake County between July 16 and August 27, 2016.

The following requested a waiver of Rule 4. Certification of Emergency Medical Technicians 836 IAC 4-4-1 General certification provisions Authority: IC 16-31-2-7 Affected: IC 16-31-3 Sec. 1 which reads (a) Applicants for original certification as an emergency medical technician shall meet the following requirements: (1) Be a minimum of eighteen (18) years of age. (2) Successfully complete the Indiana basic emergency medical technician training course as approved by the commission and administered by a certified training institution. (3) Pass the emergency medical technician written and practical skills examinations as set forth and approved by the commission. (b) The applicant shall apply for certification on forms provided by the agency postmarked within one (1) year of the date that the course was concluded as shown on the course report. Mr. Radcliff is requesting additional time to complete his EMT written exam. Mr. Radcliff's course ended on April 27, 2015. He has taken his first attempt on January 21, 2016 and received a failing grade. He has completed the other requirements. Staff recommends: 90 days to complete and pass the written exam

A motion was made by Commissioner Zartman to approve staff recommendation. The motion was seconded by Commissioner Lockard. The motion passed.

The following requested a waiver of SECTION 50. (a) Application for certification as an advanced emergency medical technician shall be made on forms provided by the agency. An applicant shall: (1) complete the required forms; and (2) submit the forms to the agency. (b) All applicants for original certification shall provide evidence of compliance with the requirements for certification. (c) Certification as an advanced emergency medical technician shall be valid for two (2) years. (d) Individuals who have failed to comply with the continuing education requirements shall not exercise any of the rights and privileges nor administer advanced life support services to emergency patients. Mr. Taylor is requesting additional time to complete his ADV EMT continuing education hours. Mr. Taylor's certification expires on June 30, 2016 and he is requesting additional time as he has undergone three surgery's and has been off work 7 months during his 2 year certification period.

A motion was made by Commissioner Zartman to approve the waiver request and give Mr. Taylor 90 days to complete his continuing education hours. The motion was seconded by Commissioner Hamilton. The motion passed.

The following requested a waiver of Rule 4. Certification of Emergency Medical Technicians 836 IAC 4-4-1 General certification provisions Authority: IC 16-31-2-7 Affected: IC 16-31-3 Sec. 1 which reads (a) Applicants for original certification as an emergency medical technician shall meet the following requirements: (1) Be a minimum of eighteen (18) years of age. (2) Successfully complete the Indiana basic emergency medical technician training course as approved by the commission and administered by a certified training institution. (3) Pass the emergency medical technician written and practical skills examinations as set forth and approved by the commission. (b) The applicant shall apply for certification on forms provided by the agency postmarked within one (1) year of the date that the course was concluded as shown on the course report. Ms. Veith is requesting additional time to complete her written exam. Ms. Veith course ended on December 20, 2014. She took her first attempt on December 16, 2015 and

received a failing score (62.50%), she them took her second attempt on January 20, 2016, a month after her one year deadline and received a failing grade. She has completed remediation as of April 4, 2016.

A motion was made by Commissioner Zartman to allow sixty (60) days to take her final attempt at the written exam and take the practical exam again since her exam is over a year old. The motion was seconded by Commissioner Lockard. The motion passed.

PROVIDER WAIVER REQUESTS

The following requested a waiver of Rule 2. Requirements and Standards for Paramedic Organizations 836 IAC 2-2-1 General requirements for paramedic provider organizations which reads (h) A paramedic ambulance service provider organization must be able to provide a paramedic level response. For the purpose of this subsection, "paramedic response" consists of the following: (1) A paramedic. (2) An emergency medical technician or higher. (3) An ambulance in compliance with the requirements of section 3(e) of this rule. (4) During transport of the patient, the following are the minimum staffing requirements: (A) If paramedic level advanced life support treatment techniques have been initiated or are needed: (i) the ambulance must be staffed by at least a paramedic and an emergency medical technician; and (ii) a paramedic shall be in the patient compartment. (B) If an emergency medical technician-intermediate level advanced life support treatment techniques have been initiated or are needed: (i) the ambulance must be staffed by at least an emergency medical technician-intermediate and an emergency medical technician; and (ii) an emergency medical technician-intermediate shall be in the patient compartment. (C) If advanced life support treatment techniques have not been initiated and are not needed: (i) the ambulance must be staffed by at least an emergency medical technician; and (ii) an emergency medical technician shall be in the patient compartment. Knox County EMS is requesting a waiver of staffing. Knox County states that they have an inability to always have an EMT available to run with a paramedic.

Knox County EMS

A motion was made by Commissioner Lockard to deny the waiver for normal day to day operations but grant a waiver for a second truck out or in an emergency situation with the requirement to report to their district manager when they have to use the waiver. The motion was seconded by Commissioner Hoggatt. Discussion followed. The motion was amended by Commissioner Lockard to deny the waiver for normal day to day operations but grant a waiver for a second truck out or in an emergency situation with the requirement to report to their district manager when they have to use the waiver. The waiver will be good for 6 months and that someone from Knox County EMS be present at the next Commission meeting to discuss the waiver. The amended motion was seconded by Commissioner Zartman. Commissioner Mackey abstained from the vote. The vote was taken and the amended motion passed. The Commission would also like to know what steps are being taken by Knox County EMS to correct their situation.

The following requested a waiver of 836 IAC 1-4-2 Emergency medical services vehicle radio equipment Sec. 2 which reads (a) All communication used in emergency medical service vehicles for the purpose of dispatch or tactical communications shall demonstrate and maintain the ability to provide a voice communications linkage with the emergency medical service provider organization's dispatch center within the area that the emergency medical service provider organization normally serves or proposes to serve. (b) Communication equipment used in emergency medical services vehicles shall be appropriately licensed through the Federal Communications Commission, when applicable. The maximum power of the transmitter shall be not more than the minimum required for technical operation, commensurate with the: (1) size of the area to be served; and (2) local conditions that affect

radio transmission and reception. (c) All emergency medical services vehicles shall be equipped with two (2) channels or talk-groups as follows: (1) One (1) channel or talk-group shall be used primarily for dispatch and tactical communications. (2) One (1) channel or talk-group shall be 155.340 MHz and have the proper tone equipment to operate on the Indiana Hospital Emergency Radio Network (IHERN) unless the provider organization vehicles and all the destination hospitals within the operational area of the provider organization have a system that is interoperable with the Indiana statewide wireless public safety voice and data communications system. Patients Transport Service is requesting a waiver of the communications rule requiring one channel to be IHERN. Their primary communication is cellular phone and tablet computers in the ambulance. Not all ambulances are equipped with two way radio's and the ones that do are not compatible with the IHERN network.

Patient Transport Services

A motion was made by Commissioner Mackey to approve the waiver. The motion was seconded by Commissioner Zartman. The motion passed.

The following requested a waiver of Rule 2. Requirements and Standards for Paramedic Organizations 836 IAC 2-2-1 General requirements for paramedic provider organizations which reads (h) A paramedic ambulance service provider organization must be able to provide a paramedic level response. For the purpose of this subsection, "paramedic response" consists of the following: (1) A paramedic. (2) An emergency medical technician or higher. (3) An ambulance in compliance with the requirements of section 3(e) of this rule. (4) During transport of the patient, the following are the minimum staffing requirements: (A) If paramedic level advanced life support treatment techniques have been initiated or are needed: (i) the ambulance must be staffed by at least a paramedic and an emergency medical technician; and (ii) a paramedic shall be in the patient compartment. (B) If an emergency medical technicianintermediate level advanced life support treatment techniques have been initiated or are needed: (i) the ambulance must be staffed by at least an emergency medical technician-intermediate and an emergency medical technician; and (ii) an emergency medical technician-intermediate shall be in the patient compartment. (C) If advanced life support treatment techniques have not been initiated and are not needed: (i) the ambulance must be staffed by at least an emergency medical technician; and (ii) an emergency medical technician shall be in the patient compartment. Patients Transport Service is requesting a waiver of the staffing requirements for an ALS response. They would like to replace the paramedic with a Indiana licensed registered nurse when taking a patient from Dearborn County Hospital to primary specialty centers in Cincinnati and other cities.

Patient Transport Services

A motion was made by Commissioner Zartman to approve the waiver for interfaculty transfers. The motion was seconded by Commissioner Hoggatt. Discussion followed. The motion was amended by Commissioner Zartman to make the waiver a two year waiver. The amendment was seconded by Commissioner Bowman. The amended motion passed.

Training Institution Waiver Request

The following requested a waiver of Rule 2. Emergency Medical Services Training Institution 836 IAC 4-2-1 General requirements for training institutions; staff Sec. 1 which reads (a) All institutions administering or seeking to administer emergency medical services training programs shall: (g) Certified advanced life support training institutions conducting paramedic training programs on or after July 1, 2008, shall show written proof of national accreditation of the program. Ivy Tech Valparaiso is requesting a waiver to be able to conduct a paramedic training

program to gain their nations accreditation. They have received their letter of review and are working through the process.

Ivy Tech Valparaiso

A motion was made by Commissioner Zartman to approve the waiver. The motion was seconded by Commissioner Lockard. The motion passed.






