#### CALL TO ORDER AND ROLL CALL

Meeting called to order at 10:00am by Chairman Lee Turpen. Mrs. Candice Pope called roll and announced quorum. Mr. Tom Baten welcomed the Commission and members of the EMS community to Crawfordsville.

#### **ADOPTION OF MINUTES**

a. Adoption of minutes from the March 24, 2017 session.

Commissioner Mackey stated that an amendment needed to be made to the Fort Wayne Fire Department waiver Commissioner Zartman and Commissioner Brown abstained not Commissioner Zartman and Commissioner Hamilton.

A motion was made by Commissioner Mackey to accept the minutes with the mentioned amendment from the August meeting. The motion was seconded by Commissioner Hoggatt. The motion passed.

#### **Honorary Certifications**

#### INDIANA DEPARTMENT OF HEALTH

- a. Mr. Art Logston reported for the Department of Health. Mr. Logston reported Union Hospital of Terre Haute's one year of "in the process" verification is up but they have been approved to continue as "in the process" their site visit is scheduled for the end of June. IU Bloomington has been verified as a level 3 trauma center. Methodist of Gary is being verified yesterday (May11) and today (May 12) should know something soon, Reid Health will have their verification visit June 13 and 14, Community Hospital of Anderson's visit is scheduled for July 11 and 12, and Regional Hospital in Terre Haute will have their visit in August.
- b. EMS medical Directors conference was a successful event 118 were in attendance two weeks ago.
- c. Injury Prevention conference will be held on May 15, 2017 at Connor Prairie welcome center.
- d. Trauma groups are up and going in Districts 1, 2, 3, 5, 6, 7, and 10
- e. There are child safety technician scholar ships in an effort to have more child safety technicians available
- There has been a second round of Narcan distribution to local Health Departments. Director Garvey and Mr. Logston discussed the narcan cashes for providers they have access if there is a rush for it.

Commissioner Mackey asked about the list that was in the packer (see attachment #1) Director Garvey commented on the list, it is in regards to run reports not being left at the hospital by providers. More discussion will be held later in the meeting.

#### EMS FOR CHILDREN (EMSC)

Ms. Margo Knefelkamp reported there have been 3 videos developed on u tube channel IEMSC.org. The three videos are serving for emergency medical care providers, the IEMSC mission, and Indiana school nurse course. On the 24th the IEMSC hosted the Indiana school nurse course. 25 school nurses attended the course. The IEMSC hero breakfast is 9am-11am on Wednesday of EMS week please send rsvp through Ms. Knefelkamp or through the IEMSC website. The IEMSC survey is at 42% for responses. Ms. Knefelkamp is working with Ms. Robin Stump to send out another communication regarding the survey. March 1st is the beginning of the grant applications.

#### TECHNICAL ADVISORY COMMITTEE (TAC)

No report given at this meeting.

#### INDIANA EMERGENCY MEDICAL SERVICES ASSOCIATION (IEMSA)

Mr. Nate Metz reported out for IEMSA. Mr. Metz announced that the date for the conference to December 1st. It will be a one day conference. There will be National recognized EMS people speaking at this year's conference. The conference will be held at the Professional Fire fighters Hall in Indianapolis. The last association meeting was held in Fort Wayne the association is working with three different agencies to join the association to expand it. They discussed legislation that they hope to introduce in 2018. The association is working on legislation for more timely Medicaid/Medicaid reimbursements.

#### **EMS EDUCATION WORKING GROUP**

Mr. George Schulp reported. The group is meeting every other month. Their schedule is on their website leeg.org. They are working to get more PI's to join to help with projects. Some of the projects that are underway are working on LMS courses for the state such as IV maintenance, comparing the PI and Fire Instructors courses for crossing over from one to the other, working on compiling data for PI and Tis and set some best practices.

#### PERSONNEL WAIVER REQUESTS

The following requested a waiver of 836 IAC 4-9-5 Continuing education requirements Authority: IC 16-31-2-7; IC 16-31-3-14; IC 16-31-3-14.5; IC 16-31-3-20 Affected: IC 16-31-3-8; IC 16-31-3-20 which reads: Sec. 5. (a) To renew a certification, a certified paramedic shall submit a report of continuing education every two (2) years that meets or exceeds the minimum requirements in subsection (b). (b) An applicant shall report a minimum of seventy-two (72) hours of continuing education consisting of the following: (1) Section IA, forty-eight (48) hours of continuing education through a formal paramedic refresher course as approved by the commission or forty-eight (48) hours of supervising hospital-approved continuing education that includes the following: (A) Sixteen (16) hours in airway, breathing, and cardiology. (B) Eight (8) hours in medical emergencies. (C) Six (6) hours in trauma. (D) Sixteen (16) hours in obstetrics and pediatrics. (E) Two (2) hours in operations. (2) Section IB, attach a current copy of cardiopulmonary resuscitation certification for the professional rescuer. The certification expiration date shall be concurrent with the paramedic certification expiration date. (3) Section IC, attach a current copy of advanced cardiac life support certification. The certification expiration date shall be concurrent with the paramedic certification expiration date. (4) Section II, twenty-four (24) additional hours of emergency medical services related continuing education; twelve (12) of these hours shall be obtained from audit and review. The participation in any course as approved by the commission may be included in this section. (5) Section III, skill maintenance (with no specified hour requirement). All skills shall be directly observed by the emergency medical service medical director or emergency medical service educational staff of the supervising hospital either at an inservice or in an actual clinical setting. The observed skills include, but are not limited to, the following: (A) Patient medical assessment and management. (B) Trauma assessment and management. (C) Ventilatory management. (D) Cardiac arrest management. (E) Bandaging and splinting. (F) Medication administration, intravenous therapy, intravenous bolus, and intraosseous therapy. (G) Spinal immobilization. (H) Obstetrics and gynecological scenarios. (I) Communication and documentation. Mr. Alter is requesting a waiver to accept his paramedic in-service to be accepted late. He completed all in-service requirements prior to his expiration date of March 31, 2017 except for his ACLS certification. He was unable to find a course prior to his expiration date. Staff Recommends: Approval of late in-service but to also pay the \$50 late fee.

(a) To obtain paramedic certification based upon reciprocity, an applicant shall be affiliated with a certified paramedic provider organization and be a person who, at the time of applying for reciprocity, meets one (1) of the following requirements: (1) Possesses a valid certificate or license as a paramedic from another state and who successfully passes the paramedic practical and written certification examinations as set forth and approved by the commission. Application for certification shall be postmarked or delivered to the agency office within six (6) months after the request for reciprocity. (2) Has successfully completed a course of training and study equivalent to the material contained in the Indiana paramedic training course and successfully completes the written and practical skills certification examinations prescribed by the commission. (3) Possesses a valid National Registry paramedic certification. (b) Notwithstanding subsection (a), any nonresident of Indiana who possesses a certificate of license as a paramedic that is valid in another state, upon residing at an Indiana address, may apply to the agency for temporary certification as a paramedic. Upon receipt of a valid application and verification of valid status by the agency, the agency may issue temporary certification that shall be valid for: (1) the duration of the applicant's current certificate or license; or (2) a period not to exceed six (6) months from the date that the reciprocity request is approved by the director; whichever period of time is shorter. A person receiving temporary certification may apply for full certification using the procedure required in section 1 of this rule. (NR expiration date 3/31/14??) He did take and pass his NR cognitive exam on January 2, 2017 and took a psychomotor exam on April 22, 2017 but failed the exam. Staff Recommends: Denial – Require NR certification to receive Indiana Licensure

The following is requesting a waiver of Emergency Rule LSA Document #12-393(E) which reads: Section 49 (f) Advanced emergency medical technicians shall: (1) not perform a procedure for which the advanced emergency medical technician has not been specifically trained: (A) in the Indiana emergency medical technician basic and the Indiana advanced emergency medical technician curriculums; or (B) that has not been approved by the commission as being within the scope and responsibility of the advanced emergency medical technician; The following individuals are requesting a waiver to use the

Morgan lens, CPAP and the following medications while working at the United States Steel facility: Cyanokit Epinephrine 1:10,000 Toradol Zofran ODT Atrovent Staff Recommends: Approval based on previous Commission action. Staff Recommends: Approval based on previous Commission action.

#### PROVIDER WAIVER REQUESTS

The following is requesting a waiver of 836 IAC 2-2-1 which reads: (h) A paramedic ambulance service provider organization must be able to provide a paramedic level response. For the purpose of this subsection, "paramedic response" consists of the following: (1) A paramedic. (2) An emergency medical technician or higher. (3) An ambulance in compliance with the requirements of section 3(e) of this rule. (4) During transport of the patient, the following are the minimum staffing requirements: (A) If paramedic level advanced life support treatment techniques have been initiated or are needed: (i) the ambulance must be staffed by at least a paramedic and an emergency medical technician; and (ii) a paramedic shall be in the patient compartment. Lutheran Hospital is requesting a renewal waiver of the staffing requirement for a paramedic level transport. They would like to be able to staff their ground unit on occasion with an EMT or higher and an RN. With the RN in the patient compartment functioning independently. Staff recommends: approval - Based on previous Commission action with the required e-mail to area district manager each time this occurs

Lutheran Hospital of Indiana Critical Care Transport

#### CALL TO ORDER:

The meeting was called to order by Chairman Gary Miller. Rebecca Blagrave called the roll and advised the chairman that a quorum was present. Chairman Miller expressed appreciation for the use of the facility.

#### ADOPTION OF MINUTES:

Michael Olinger offered a motion to approve the minutes of the January 23, 2009 meeting. The motion was seconded by Myron Mackey. The minutes were approved.

#### STAFF REPORTS:

#### EMS PERSONNEL CERTIFICATION

John Buckman reported that the agency has implemented on-line recertification at the First Responder level on a voluntary basis. He urged people to recertify early. Mr. Buckman also asked the commission for permission to create a test review committee. Dr. Olinger offered a motion to endorse the creation of a test review committee. The motion was seconded by Lee Turpin. The motion passed.

Mr. Buckman offered a proposed rule change to address the issue of renewal applications that are filed late. Proposed language includes: Initial certification as an emergency medical technician shall be valid for a period of two (2) years plus the number of calendar days from the date the application is approved by the commission staff to the first day of the next succeeding calendar quarter, i.e. January 1, April 1, July 1, December 1.

If a properly completed renewal application is submitted within sixty (60) calendar days after the expiration date of the certification, together with the required documentations to show that the applicant has completed all required continuing education within the two (2) years prior to the expiration of the certification and a fifty dollar (\$50) reapplication fee, the certification will be reinstated on the date that the commission staff determines that the required application, documentation and re-application fee have been properly submitted. The expiration date will be two (2) years from the expiration of the previous, expired certification.

Agency counsel, Mara Snyder suggested a different wording for the term "reapplication fee." She also commented that the commission can not issue a recertification retroactively. Randy Seals questioned if there are liability issues if someone practices under an expired certificate during the 60 day or so period. William Rutherford reminded those present that it was not the state's responsibility to prevent lawsuits. People need to take responsibility for their own actions.

Randy Fox asked if personnel should be required to submit renewal applications prior to the expiration date to prevent a lapse in certification. Mr. Mackey asked when the best time would be for public comment. Ms. Snyder responded that we needed to get the process in place now and that the wording can be amended during a rule re-write. Mr. Buckman offered the possibility of holding a public rule meeting at a later date to allow for public comment.

Dr. Olinger offered a motion to accept the proposed rule change with the change of the word "December" to "October. " The motion was seconded by Mr. Mackey. The motion passed.
