## **FY2023 NSGP-UA APPLICATION INSTRUCTIONS**

The maximum amount for an individual application is \$150,000. If an organization applies for multiple sites, the total of up to three applications submitted by the individual organization cannot exceed \$450,000. To receive NSGP-UA, organizations MUST BE LOCATED in Hamilton or Marion Counties.

An eligible nonprofit organization must:

- 1. Meet the description under section 501(c)(3) of the Internal Revenue Code of 1986 (IRC) and be exempt from tax under section 501(a) of such code, and
- 2. Be able to demonstrate, through the application, that the organization is at high risk of a terrorist attack.

Nonprofit organizations must have a Unique Entity Identifier (UEI), which is obtained through SAM.gov. Nonprofit organizations must register in SAM.gov to obtain the UEI but are not required to maintain an active registration in SAM.gov. Guidance on obtaining a UEI in SAM.gov can be found at <u>GSA UEI Update</u> and <u>SAM.gov Update</u>.

Applicants must submit their applications to the state administrative agent (SAA) for this grant, the Indiana Department of Homeland Security, at <a href="mailto:grants@dhs.in.gov">grants@dhs.in.gov</a>. Applications must be received by April 25, 2023, at 5 p.m. EDT. **Do not submit applications directly to FEMA or through Grants.gov**.

## Eligible applicants must complete and submit the following five documents:

- Applicants must use the FY2023 NSGP Investment Justification Form available at <a href="https://www.in.gov/dhs/grants-management/grants-management/nonprofit-security-grant-program/">https://www.in.gov/dhs/grants-management/grants-management/nonprofit-security-grant-program/</a>.
  Additional resources are also available to assist in the grant application process. Applicants should select YES to the question "Are you physically located in a current Urban Area Security Initiative designated urban area?" and then select Indianapolis from the dropdown list on page two.
  - Use the file naming convention: FY2023 NSGP UA IN < Nonprofit's Legal Name>
- 2. In addition to the investment justification form, applicants must provide a **mission statement** that explains the nature of the applicant organization's purpose and mission. This primarily will be used to validate the organization's type as either:
  - a. ideology-based/spiritual/religious;
  - b. educational;
  - c. medical; or
  - d. other.

The mission statement should be provided on the organization's official letterhead.

- 3. Applicants must also provide the **vulnerability assessment**, upon which the request in the application is based. There is no specified or required format for the vulnerability assessment. If an organization has already conducted a vulnerability assessment for the site it is applying for, it can use a previous assessment as long as there have been no substantive changes that would make the assessment invalid or inaccurate.
- 4. Applicants must also provide a completed and signed **W-9 form**. This will expedite the process to obtain a Supplier ID from the state of Indiana. If an organization already has a Supplier ID, please include that Supplier ID number on the submission email along with the W-9 Form.
- 5. Applicants must also provide a completed and signed **Automated Direct Deposit form**. This will expedite the process to obtain a Supplier ID from the state of Indiana. If an organization already has a Supplier ID, please include that Supplier ID number on the submission email along with the Automated Direct Deposit Form.

Submissions must include all five (5) documents to be considered for submission to FEMA.

Investment justification forms must remain in PDF format and the space available. Do not convert to another application or add additional pages. Do not scan these pages as they must be submitted as fillable forms.
