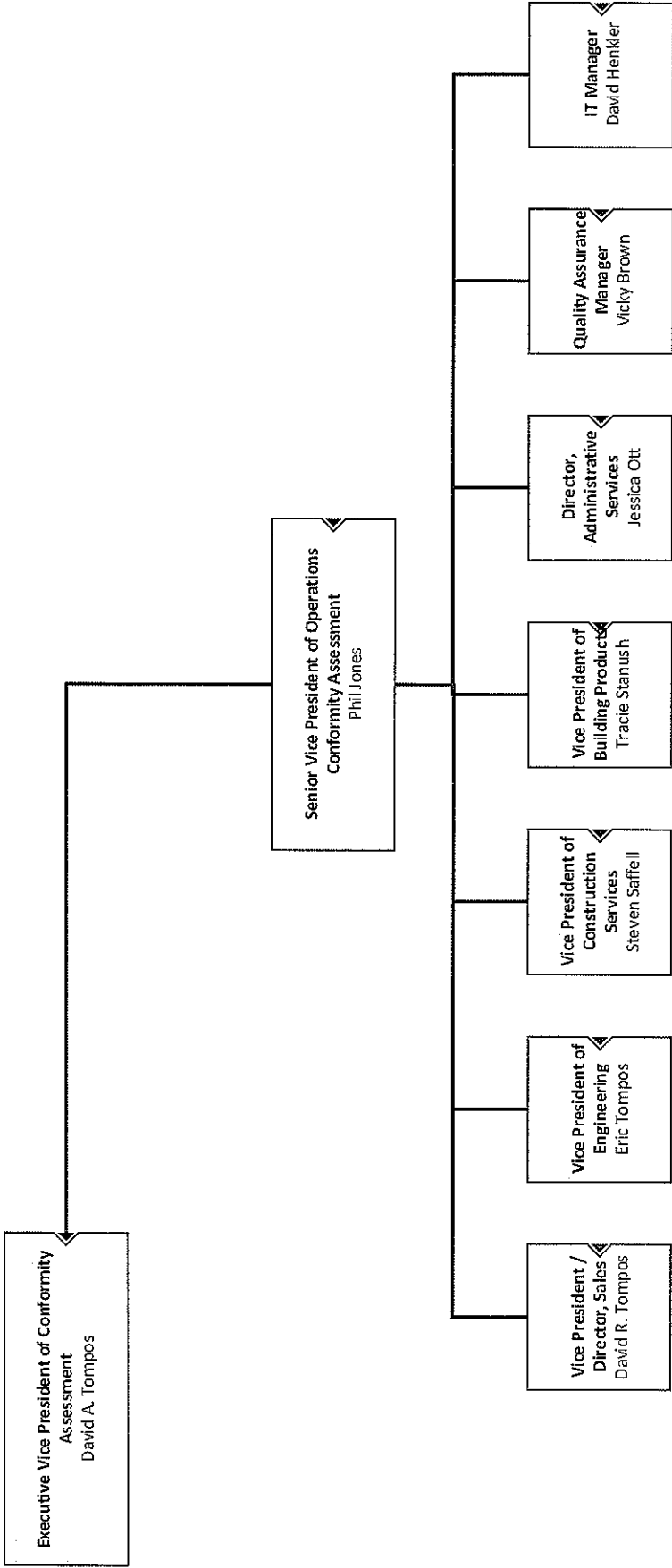

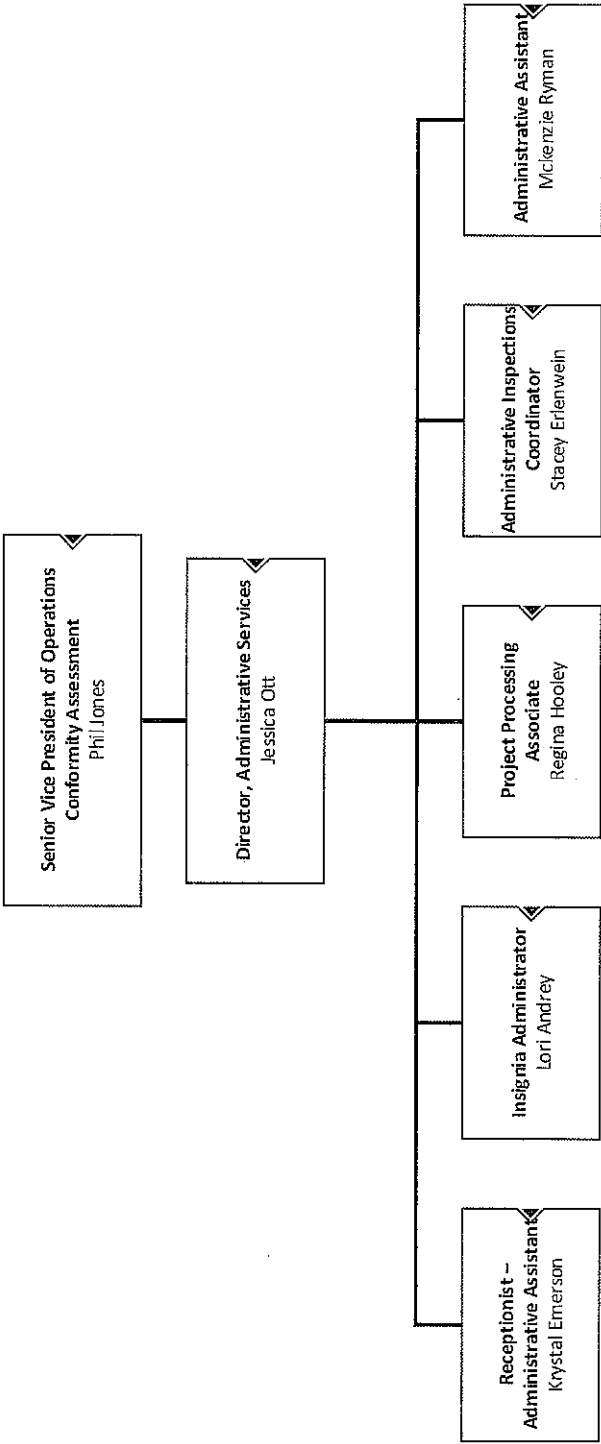

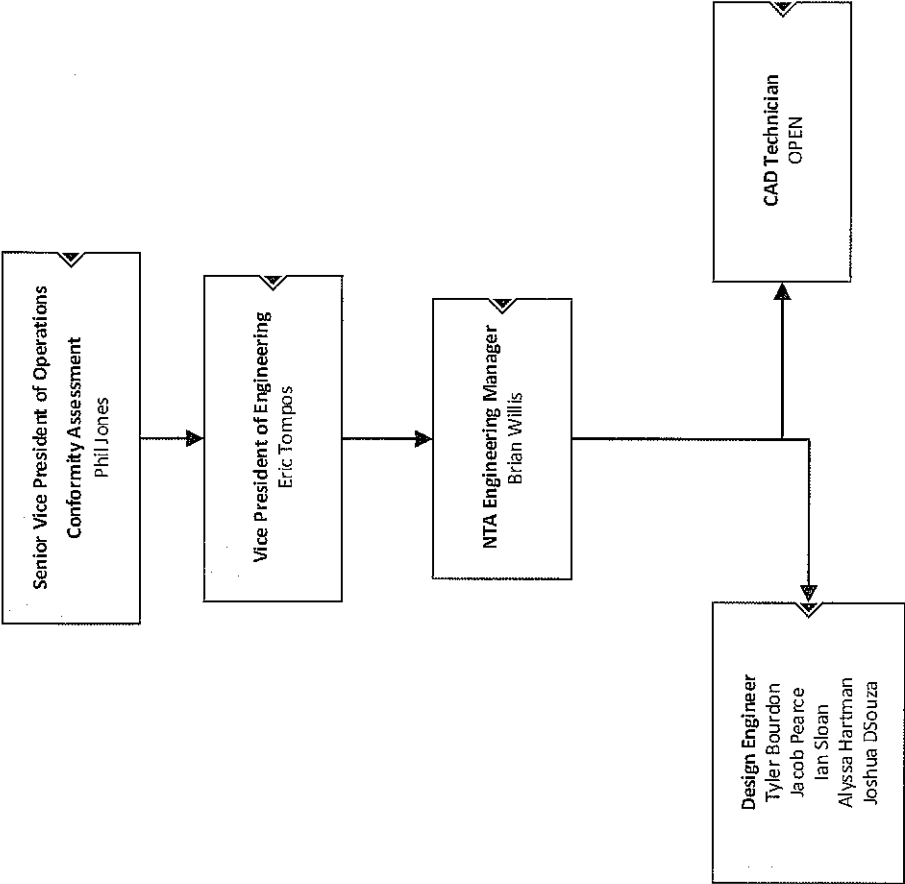
ICC NTA, LLC. Organizational Chart



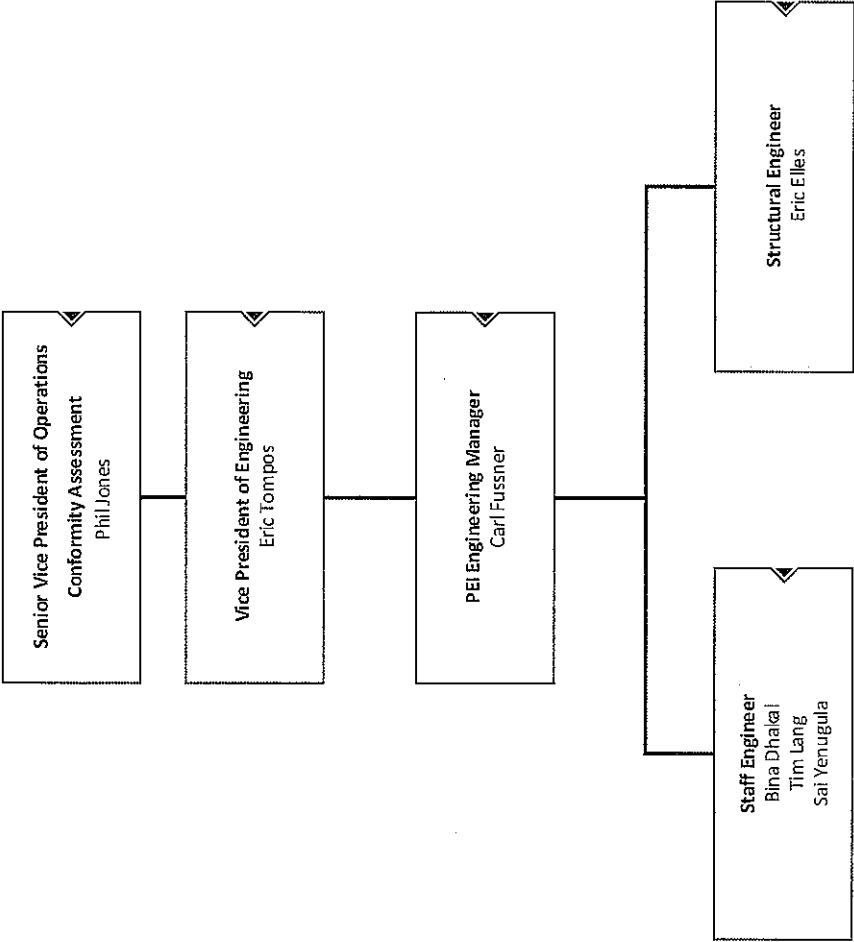
