**OLD BUSINESS**

***IERC Handbook Update***

Chairman Thacker informed the IERC of a staffing change within IDHS. Elliot Anderson has moved from legal counsel to Deputy Director of Administration. Justin Guedel will function as counsel for IDHS at these meetings and has stepped in to assist in completion of the handbook update. Mr. Guedel also informed the IERC that he will provide recommendations to the IERC on behalf of the IDHS and assist the IERC as appropriate, however, he does not function as counsel for the IERC, as that role is reserved for the Office of the Attorney General.

**NEW BUSINESS**

***2021 LEPC Funding***

Ms. Horner reported that staff is recommending the IERC award funding to 85 LEPCs for 2021, regardless of noncompliance with the exercise or meeting requirements. Cass, Decatur, Fayette, Marshall, Martin, Orange, and Switzerland counties were found to be noncompliant by staff and are recommended to not receive funding for 2021. Ms. Horner continued to report that Marshall and Switzerland Counties submitted some reports however failed to submit a fiscal report,

bylaws and the LEPC Hazardous Materials Response Plan. Mr. French made a motion to approve LEPC funding as recommended by staff and Mr. Palin seconded the motion.

If the IERC wishes to have a speaker or programing at the conference, all cost associated will be covered by the IERC. Mr. Hamby will serve as a liaison for the IERC and attend EMAI planning meetings.

#### **PUBLIC COMMENTS**

Mr. Hamby informed the IERC that several LEPCs reached out to him or his counterparts for LEPC exercise ideas. He reported an accident recently happened in LaPorte County that would make a great exercise. The accident involved a tanker truck hauling hazardous materials being rear-ended at a railroad crossing. He continued to say this would be a good scenario for a virtual tabletop exercise.




