#### <u>Reports</u>

Dr. Kaufmann gave a brief update on the state of Mobile Integrated Health (MIH) in the state of Indiana and the Nation. He said he was excited to see the growth of MIH here in Indiana. Dr. Kaufmann also announced his resignation and that today was his last day with IDHS.

Grant Status - Brittany Fortinberry reported that the agency has moved forward with the contracts and some programs have received their money.

Director Kinney gave an update on legislation.

#### Program Overview

Wheeler Mission – Alicia Dinkeldien gave an overview of their program.

Dinkeldien talked about the resources that are covered at the mission including addiction recovery, counseling, job and life skills training, adult education, mentorship, aftercare and more. She discussed the programs and the drop in 911 calls to the mission since she has been embedded in the mission.

## Old Business

Chairman Kinney started the discussion on education requirements for MIH programs. After some discussion Fortinberry will do some further research to bring back recommendations/information to the group.

## New Business

Brittany Fortinberry reviewed the application and the information that is being collected. Director Kinney reviewed the reason for the application process. Fortinberry gave an overview of the pending applications: Phoenix Paramedic Solutions, Warsaw-Wayne Fire Territory, Scott Township Fire and EMS, and Lutheran EMS programs.
