## **Reports**

Director Kinney welcomed all to the MIH Committee meeting. He reported that there was a great Indiana presence at Atrium Health MIH Conference in Savannah, GA with multiple presenters and the Crawfordsville MIH program was recognized as the Spotlight Program of the conference. He let all know about the new EMS Dispatch monthly newsletter, stating that the recent conference is highlighted in April's addition.

Dr. Yazel stated the importance of keeping up with legislation as they are reviewing budgets, and due to some recent changes, the local health departments could see a significant decrease in funding. This could lead to issues with some MIH programs that rely heavily on their partnership with their LHD.

Director Kinney reviewed the most recent legislative updates. He reported that legislation is currently in session and there are multiple bills addressing MIH, but they are also determining budget this session which could lead to IDHS continuing the MIH grant moving forward.

## **New Business**

Emily Castor presented the five MIH program applications: North Vernon Fire Department, Salem – Washington Township Fire Department, Spencer County Emergency Ambulance Service INC., Starke County Ambulance Service, and Warren County EMS.
