I do intend to be present at the February 5, 2019 meeting of the Fire Prevention and Building Safety Commission. I would make the following requests:

1. An opportunity to answer questions or provide testimony at the meeting.
2. Given the nature of this issue, the confusion surrounding it, and the very real possibility of similar scenarios occurring around the state of Indiana, I would suggest that a non-rule policy be written by either the Fire Prevention & Building Safety Commission or the State Building Commissioner to provide clear guidelines to both the enforcement community and contractors moving forward.
