<b>Subject Matter of the Rule</b>	
Amends 675 IAC 12-3-13 to clarify the language, and repeal outdated provisions, concerning fees for boiler and pressure vessel inspection, permitting, inspector licensing, and variances. Amends, repeals, and adds sections to 675 IAC 30 to modernize the regulations governing the design, manufacture, fabrication, assembly, installation, alteration, repair, maintenance, operation, and inspection of regulated boilers and pressure vessels.
