
Dear Ms. Walters:

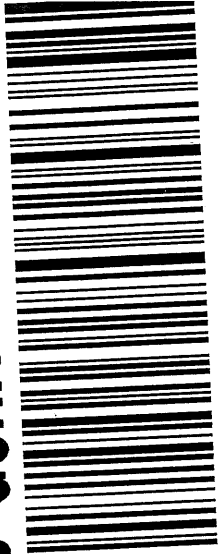

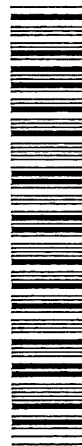
