Overview

What is PPOP-IN?

- The new, 24/7, self-service Personal Property Online Portal for Indiana (“PPOP-IN”) will allow taxpayers and authorized agents to file their personal property return online. Taxpayers will also have the ability to upload additional personal property forms and any necessary supporting documentation.
- The Department has partnered with XSoft to develop this new system.



Overview

- Seven (7) property tax forms available:
 - Form 102
 - Form 103 Short
 - Form 103 Long
 - Form 103-N
 - Form 103-0
 - Form 104
 - Form 106
- Note: Preparer's will also have the ability to attach other personal property forms that are needed with their submission.



Overview

When will PPOP-IN be available?

- The Department will unlock the system in January 2022.
- Taxpayers can file their Business Personal Property Return(s) online now at <https://ppopin.in.gov>.

Support Materials

- PPOP-IN has two main areas where you can review Support Materials:
 - Help Pages
 - FAQ Pages
- Located in the top navigation bar.
- Specific to your user type when logged in.



Overview of Data Flow

- Taxpayer/Agent complete a filing.
- Filing is forwarded to the appropriate assessor's office.
- Assessors review the filing in the same manner they review paper filings and mark the filing as Accepted/Rejected.
- Taxpayer/Agent is provided a notification as to the status of the filing when it changes.



Explanation of Registration Process

- Navigate to PPOPIN.in.gov
- Select the “Register” option.
 - Continue to Access Indiana.
- Log-in or Register for a new Access Indiana Account.
- Complete PPOP-IN Registration.
 - 4 User Types Available.



Available PPOP-IN User Types

“I am an Indiana resident or property owner”

- Use this option for taxpayers.

“I am an agent representing one or more Indiana Property Owners”

- Use this option if you are filing out the form on behalf of another taxpayer. (Internal Accountants, CPAs, etc.)

“I am a county official”

- Use this option if you work for a county assessor’s office and are registering for your official capacity.

“I am a member of the DLGF”

- Use this role if you work for the DLGF.



Connecting a Taxpayer and Agent

- For an agent to file on behalf of a taxpayer, the agent and taxpayer must both agree to connect their accounts via the agent's invite code.
- PPOP-IN facilitates and manages these connections directly in the system.
- Once a taxpayer and agent have connected their accounts, the connection persists until it is revoked.

2022 Updates

- Validation Tools and System Upgrades
 - Upgrades to the system that allow for more flexibility and easier processing of returns for assessors and their staff.
 - Significant bug fixes that resolve many of the most common issues that were encountered last year (including naming issues, township selection errors, etc.).
 - Better validation for submissions so that forms that are submitted have less likelihood of being rejected.



2022 Updates

- Rollover Filings
 - Rollover capabilities for taxpayers and agents (users now can roll over previous year's data so that the filing process is easier and faster.)
- Messaging Tool
 - Assessors and taxpayers/agents will have the opportunity to send messages with each filing. This can be utilized with indicating why filings are rejected, businesses being closed, etc.



2022 Updates

- We are also working with our software vendor for the possibility of including the API software.
- A fee will not be charged in 2022 for PPOP-IN filings.

- PPOP-IN will be down for yearly rollover from:
 - 1/1/2022 – 1/12/2022.
