**RE:** Update to 50 IAC 26 Code Lists

**DATE:** March 16, 2023

The purpose of this memorandum is to inform county assessors and property tax management system software vendors about updates to the following code lists as referenced in 50 IAC 26 and defined in the Property Tax Management System Code List Manual: Code List 6 - Land Type Codes and Code List 63 – Return Type Codes.

Under 50 IAC 26-20-3, the Department of Local Government Finance ("Department") and Legislative Services Agency ("LSA") jointly manage code lists for required data submissions. Effective March 16, 2023, the entries that are bolded and highlighted in the tables below are to be added to the respective code lists.

Please note that due to the deadline for county assessors to submit their 2022 Pay 2023 real and personal property data files having already passed, the new entries added to Code List 6 and Code List 63 will not pertain to the 2022 Pay 2023 real and personal property data submission. Instead, the new entries will pertain to the real and personal property data submissions for the 2023 Pay 2024 cycle and going forward.

## PERSONAL PROPERTY FILE

The Exempt Non-Filer return type code, which is being added to Code List 63, will go into effect starting with personal property tax returns filed in 2023. This new return type code ("E") should be selected for all taxpayers who previously filed a personal property return claiming the exemption and who continues to qualify for the exemption. Under Senate Enrolled Act 382-2022, these taxpayers claiming the exemption are no longer required to file a personal property return claiming the exemption, as long as they still qualify for the exemption.

In addition to selecting return type code E, assessing officials should also enter "BPEX" in the Form Type data field for personal property taxpayers that are no longer required to file.
