The Department of Local Government Finance, under IC 6-3.5-1.1-24, hereby distributes the Local Option Income Tax (LOIT) equivalency rates for those counties that adopted the Operating Levy Freeze LOIT. This rate should be added to the certified property tax rate for purposes of the distribution of Commercial Vehicle Excise Tax (CVET), Excise Tax, and Financial Institution Tax (FIT).
