On-time property tax bills are a top priority for the Department of Local Government Finance (“Department”) for 2017 and 2018.

To achieve this objective, it is necessary for all involved in the assessment and property tax billing processes to understand that there are sequential deadlines for completing statutory responsibilities. Attached are key deadlines for calendar year 2017. The deadlines below have been adjusted to reflect the last possible day on which or by which a particular task must be performed. Failure to meet these deadlines may jeopardize on-time tax billing.

2017 Data Submission Dates

Dates may change by action of the 2017 General Assembly.

Deadlines applicable to Pay 2017

- March 1 Deadline for submission of assessors' annually assessed mobile home file (MOBILE, APPEALMH) for calendar year 2017 (affects 2017-pay-2017 tax year). 50 IAC 26-20-6(b), (c).
- March 15 Deadline for submission of auditors' tax billing data (TAXDATA, ADJMENTS) for 2016-pay-2017 taxes. IC 36-2-9-20.

Deadlines applicable to Pay 2018

- February 1 Deadline for submission of assessors' sales disclosure data (SALEDISC, SALECONTAC, SALEPARCEL) for calendar year 2016 sales (affects 2017-pay-2018 tax year). IC 6-1.1-5.5-3; 50 IAC 27-9-1(a).
- August 31 Deadline for submission of assessors' real property data (PARCEL, LAND, IMPROVE, DWELLING, BUILDING, BLDDTL, APPEAL) for the 2017-pay-2018 tax year. IC 6-1.1-4-25(b); 50 IAC 27-9-1(b).

Deadline for submission of assessors' oil & gas assessment data for those counties where applicable (OILGAS, OILGASALL) for the 2017-pay-2018 tax year. IC 6-1.1-4-25(b); 50 IAC 27-9-1(b).

Deadline for submission of assessors' personal property data (PERSPROP, POOLDATA, APPEALPP) for the 2017-pay-2018 tax year. IC 6-1.1-4-25(b); 50 IAC 27-9-1(b).
