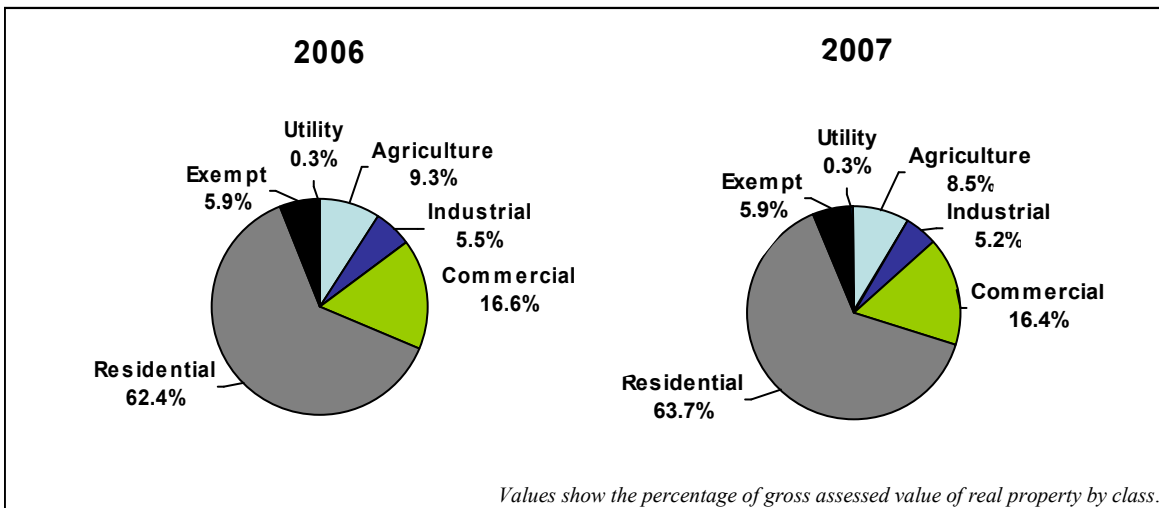

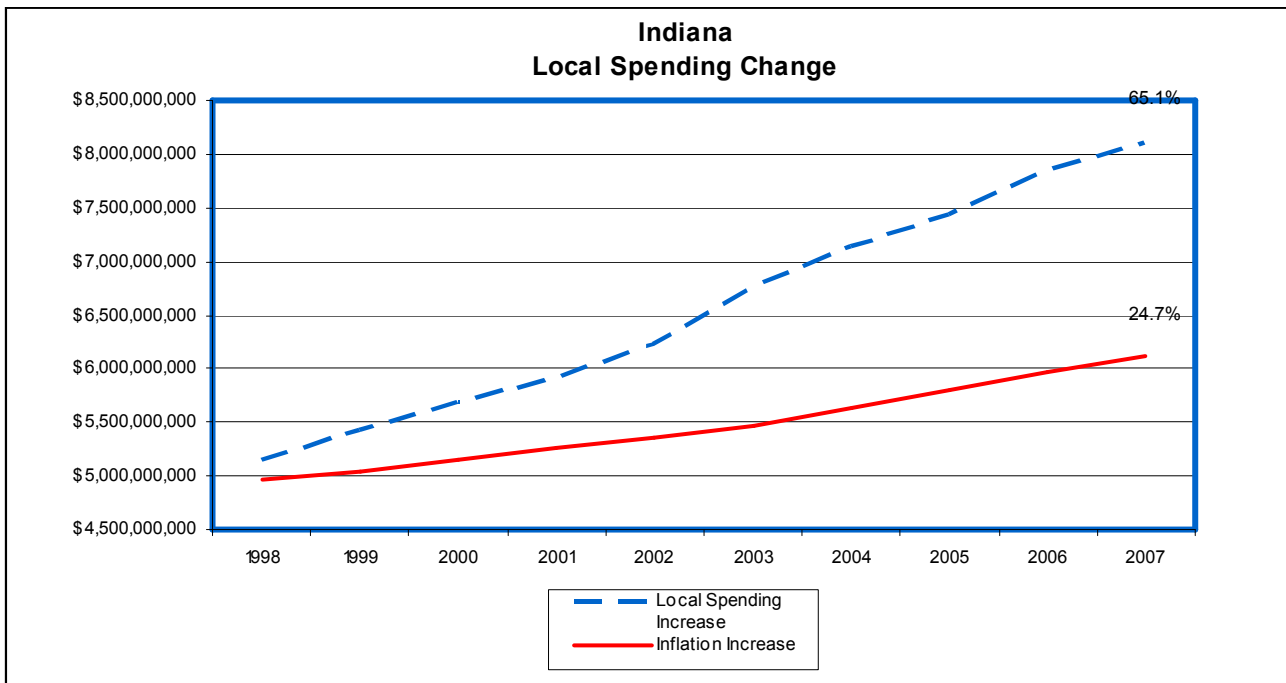
How are local governments spending property taxes?



Who pays property taxes?



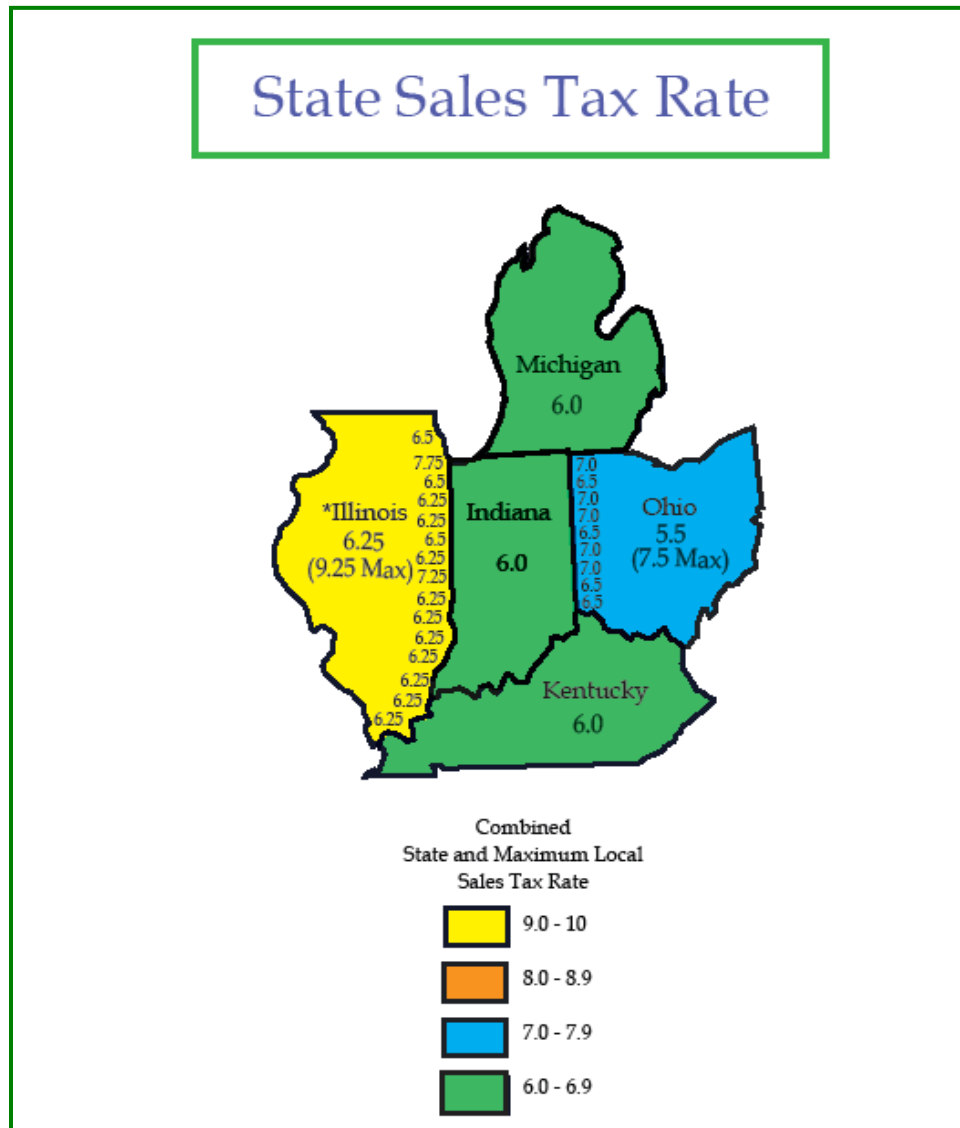
