This addendum is to become a part of the Contract Documents and shall be properly acknowledged and dated on the Bid Form by the Bidding Contractor.

- Strike item "B" from the Work not included list in the spec section 010200 Builders Risk is to be provided by the General Contractor. See section 11.2.1 on page 17 of 20 of the DAPW 26 document for additional information.
- "Outdoor Aluminum". Has been approved for bidding purposes. Final seating structure design approval will be based on pending shop drawings.
- 3. "Sturdisteel". Has been approved for the seating structure bidding purposes. Final seating structure design approval will be based on pending shop drawings.
- 4. Sheet C0.0 Under the site improvements listed scope. Strike "provide" for the picnic tables. The general contractor is to install the new picnic tables that are provided by the owner. The general contractor is to provide and install the overhead lighting as shown between buildings C,D, and E.
- 5. C2.1 The aluminum railing as called for should be along both edges of the new concrete patio between building "A" and "B". See dimensions 20.52' and 27.50' for approximate locations.
- 6. C2.2 Note that there is an insulation board plan detail for the viewing deck "B". There was not a detail callout for this scope but it is shown to the right of the "Site Plan Area 2" sheet.
- C3.1 When looking at the viewing deck "A" hatched area, the note below it should reference sheet C2.1 instead of C2.2.
- 8. Sheets S1, S3, S4 any references to a drainage pipe at various foundation locations should be for a nominal 4" corrugated perforated hdpe drain pipe with filter fabric sock.
- Sheet S12 No Roof Framing Detail #5. Install continuous C.F.S. brace at centerline of ceiling
 joist span. Brace to be 600T125-33 laid flat and fastened to each ceiling joist with (1) #10 metal
 screw.
- 10. Sheets A5 & A6 See the revisions as shown on the revised sheets included with this document. The revisions relate to dimensions for the glass railing as well as a beam cap flashing detail at the ends of all of the glulam beams.
- 11. Sheet A7 Relative to the notes between the "West Elevation" and the "North Elevation", only the piping is to be painted. The existing LP tanks are to be left as-is.
