Call to Order

Chair Ryan Mueller called the meeting to order at 1:30 p.m. sharp.

Approval of July 2023 minutes

Larrison made a motion to approve the minutes, Shaw seconded, the motion was approved unanimously.

Division Director's Report

McCord reported about activities at the upcoming State Fair. Archaeology Month events were well attended, including both in-person and virtual presentations and other events. Preserving Historic Places conference set a record for attendance at about 300 persons. The conference will reconvene in October 2024 in Madison. Applications for HPF grants were open until early October. Twenty-one applications requesting 1.1 million dollars in total were submitted and will be reviewed by staff. DHPA has adopted a new policy relating to Rehabilitation Investment Tax Credit projects that involve listing of a property on the National Register of Historic Places. The policy regards timing of the nomination process, in conjunction with completion of the project. The policy is now posted on line on DHPA's website and board policy may be revised to reflect the policy at a later date.

 Diebold presented the staff comment. Shaw made the motion to approve, Kloc seconded the motion, the motion was approved unanimously.
- 2. North Pennsylvania Street Historic District, roughly bound by Westfield Boulevard on the north, the east side of New Jersey Street on the east, 46th Street on the south, and the west side of Pennsylvania Street, Indianapolis, Marion County (2722)

 Diebold presented the staff comment. The Broughtons stated that they live on Central Avenue and asked about the process of notification and associated meetings. Diebold answered the question with assistance from Natali. Keller made a motion to approve, Larrison seconded the motion, the motion was approved unanimously.
- 3. Speakman-Miller-Kittle Farm, 10405 Old State Route 56, Rising Sun vicinity, Ohio County (2728) Diebold presented the staff comment. Larrison made a motion to approve, Shaw seconded the motion, the motion was approved unanimously.

Baptisttown Historic District, Roughly each side of Evans Avenue and the east side of Linwood Avenue between Walnut and Lincoln, each side of Lincoln Avenue between Morton and Garvin, the west side of Garvin Street and each side of Elliott Street between Mulberry and Chandler, and each side of Governor Street and Line Street between Mulberry and Bellemeade Avenue, Evansville, Vanderburgh County (2729)
 Diebold presented the staff comment. Shaw made a motion to approve, Larrison seconded the motion, the motion was approved unanimously.
- 5. Dr. Jefferson and Eliza Arnold Helm House, Rush County (2732)
 Diebold presented the staff comment. Larrison made a motion to approve, Shaw seconded the motion, the motion was approved unanimously.
- 6. Chicago Mica/Continental Diamond Fibre Co./ANCO Factory, 350 S. Campbell, Valparaiso, Porter County (2799) McCord spoke first and stated that this application was being taken out of order due to the tax credit project to revitalize the property and discussed the ramifications noted in Kurt Garner's letter to the board of October 12, 2023 (attached to these minutes). She stated that current board policy does allow for nominations to be taken out of order, if an "immediate threat" to the property exists, and she felt such a condition exists. The chair recognized Garner and he spoke in defense of the statements made in his letter. Shaw stated that she had reservations about the completeness of the National Register document as presented, especially since it appears that the rehabilitation is not complete. McCord also outlined the new National Register guidelines that DHPA has posted on its website regarding Rehabilitation Investment Tax Credit projects such as Chicago Mica and the timing for submitting National Register nominations for them. Hopefully this guidance will prevent future situations like the nomination under consideration. The board asked Diebold what information is needed to submit the application. Lighty felt the nomination should be tabled until the January meeting. Keller introduced a motion to approve the nomination and have staff submit it to the NPS, subject to inclusion of necessary materials for the application, as deemed so by staff.
