



## QUALIFIED PROFESSIONALS ROSTER for Architecture

The following consultants have been determined to meet qualification standards for cultural resource management professionals. These standards (promulgated by the National Park Service and published in 36 CFR Part 61) define the minimum education and experience required to perform identification, evaluation, registration, and treatment activities for historic properties. In some cases, additional areas or levels of expertise may be needed, depending on the complexity of the task and the nature of the properties involved. The list has been compiled by the Indiana Division of Historic Preservation and Archaeology (DHPA) as a convenience to members of the public.

Inclusion on this list does not constitute endorsement by the DHPA, nor is this list a guarantee that an individual has the specific project experience needed to meet the requirements for DHPA grant work. Furthermore, there may be other qualified consultants with whom the DHPA has not had contact that do not appear on the list.
