PUBLIC NOTICE OF INFORMAL HEARING ON PETITION FOR INVOLUNTARY INTEGRATION

The Division of Reclamation has received a petition submitted on behalf of Revitalize Resources Operating Inc. and Revitalize Resources Illinois Basin LLC ("Petitioners") requesting that certain interests be involuntarily integrated under IC 14-37-9 and 312 IAC 29-19-2 to form a unit designated as the "Reo Waterflood Unit." This notice is provided to the petitioner and each owner or lessee identified in the petition. The proposed interests to be integrated are located in Sections 30 and 31, Township 7 South, Range 6 West, Spencer County, Indiana. The hearing will be livestreamed with a link provided on the "Informal Hearing Schedule and Final Orders" webpage noted above. The purpose of the informal hearing is to gather information to assist the Division in establishing reasonable terms that provide for the equitable sharing of the proceeds of production from the unit. **Each nonconsenting owner or lessee is required to respond to the Division, and serve upon the Petitioners, at least five (5) days prior to the informal hearing a statement indicating their willingness to participate with the consenting owners in the sharing of costs for drilling and operating the well and unit.** Interested persons may attend and submit comments or objections either orally or in writing. Comments or objections concerning the petition may be submitted:

- (1) in person during the informal hearing;
