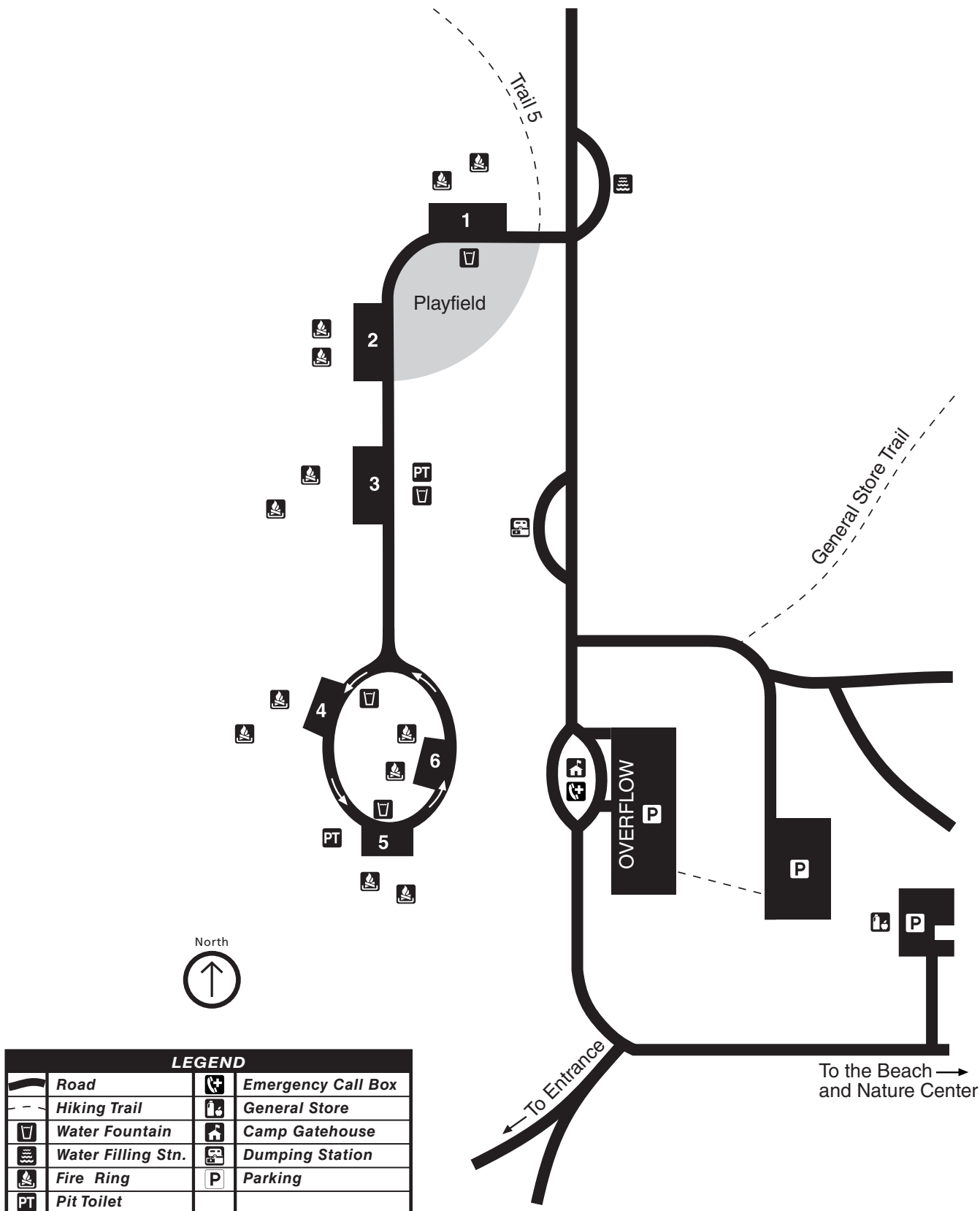

Youth Group Tent Area Campgrounds

Pit toilets, water, and level land are available for youth groups where feasible.
Space should be allocated to accommodate several groups at one time.

- **DESIGNATED AREAS:** Youth group camping is permitted in designated areas only. Each site accommodates up to 50 youths. Youths must be under adult supervision.
- **TENT-ONLY CAMPING:** The youth tent campground is tent-camping only. Where possible, one support camping unit per organization is permitted on the parking spur.
- **PARKING:** Limited parking. No parking in the grass.
- **QUIET HOURS:** 11:00 pm - 7:00 a.m.
All youth tent area campers must be at their site and quiet by those times.
- **COST & FEES:** Youth Tent reservations require the minimum payment of \$20/night plus tax (10 youths at \$2/person plus tax). The approximate number of youth will be entered into the system when a reservation is made. Any remaining fees will be collected upon arrival.
- **RESERVATIONS:** All youth tent sites are reservable but if available may be rented on a local sale basis. Reserve through the Central Reservation System at 1-866-622-6746 or camp.IN.gov.

Sat.-Sun. 12:00 p.m.-5 p.m.

- **REGISTER:** Each camping group shall register at the campground gatehouse or with the patrol person.
- **SUPERVISION:** A ratio of one responsible leader per ten campers is the recommended minimum.
- **SHOWERS:** Youth groups are directed to shower at the beach bathhouse during operating hours-Memorial Day to Labor Day, 11:00 a.m. to 7 p.m.

NOTE: Modern comfort stations and shower facilities are strictly off limits to youth group campers in the family campground area. Any one caught in violation will be asked to leave the park property.

- **ELIGIBILITY:** Youth Group campers must be under 21 years of age to fit into the group standard classification.
 - Public groups are supported wholly by public taxation and public contributions, such as school park and recreation agency programs, and welfare organization.
 - Semi-public groups or organizations are those that are not open to the public but are organized for general recreation education, public welfare, religious or other specific purposes (IE: Boy Scouts, Campfire Girls, church groups, YMCA, YWCA, and 4-H clubs).
 - Non-profit groups are those supported by membership dues and not operated by profit (IE: American Legion and service clubs such as Rotary, Boy Scouts, Lions, Kiwanis, and Izaak Walton Leagues).

SMOKING POLICY: Smoking is not allowed in any indoor facilities (cabins, screened in porches, restrooms, recreation buildings, shelters, etc). If a customer violates this policy, he/she may be asked to leave and assessed excessive cleaning fees. Smoking is allowed in open outdoor areas of the property, including campsites, however, smoking is not allowed within eight (8) feet of the entrance to a building.
