A Message from Dr. Katie Jenner

Thanks to the work of many people across Indiana, we are laser-focused on understanding what is moving the needle for students, and then maximizing that investment. This week we got a first look at outcome data from a new student learning opportunity designed to increase access to high-quality summer learning...and due to the work of many local leaders and teachers, the data is showing that it is working.

If you aren't familiar with the Summer Learning Labs, this student learning opportunity started in 2021 in Indianapolis and was one of several initiatives launched through the state's Student Learning Recovery Grant. Participating students have access to free or low-cost, high-quality math and reading instruction, along with enrichment activities. The initial partnership between The Mind Trust, United Way of Central Indiana, and many schools and educational leaders throughout Marion County was formed with the goal of accelerating student learning following the pandemic. After initial data indicated statistically significant academic growth, we partnered with The Mind Trust to invest in what is working and scale the successful Summer Learning Labs model to four additional regions across the state. This past summer, nearly 9,000 Indiana students participated.

All participating students take a pre-test before starting the Summer Learning Lab experience and a post-test in the final week to measure academic progress. At the State Board of Education meeting on Wednesday, data was shared showing that after just five weeks of intentional, high-quality instruction during the summer, students who attended the 2024 Summer Learning Labs achieved **double-digit percentage point proficiency gains** in both reading and math.

The below results represent the improvement between the Summer Learning Lab unique students' pre-test and post-test.

- All students enrolled achieved a 26 percentage point increase in English/language arts (ELA) proficiency and 24 percentage point increase in math.
- Black students achieved a 25 percentage point increase in ELA proficiency and 24 percentage point increase in math.
- Latino students achieved a 28 percentage point increase in ELA proficiency and 27 percentage point increase in math.
- Students receiving free/reduced price meals achieved a 26 percentage point increase in ELA proficiency and 24 percentage point increase in math.
- English learners achieved a 21 percentage point increase in ELA proficiency and 25 percentage point increase in math.

Completion of the NCSR is required if your school is receiving services under the State and Local Cybersecurity Grant Program (SLCGP) through the Indiana Office of Technology (IOT). The NCSR is a no-cost, anonymous, annual cybersecurity self-assessment designed to measure gaps and capabilities of school cybersecurity programs and based on the National Institute of Standards and Technology Cybersecurity Framework (NIST CSF). Schools can earn this recognition annually based on criteria that reflect a commitment to increasing college-going culture, providing opportunities for students to earn college credit, and maximizing college readiness. The AP School Honor Roll offers four levels of distinction: Bronze, Silver, Gold, and Platinum. Schools on the AP School Honor Roll may also earn the AP Access Award, honoring schools that demonstrate a clear and effective commitment to equitable access to advanced coursework. Schools earn the additional award if the percentage of AP Exam takers who are underrepresented minority and/or low-income students mirrors the school's overall student demographics.

REMINDER FROM THE INDIANA COMMISSION FOR HIGHER EDUCATION: Mitch Daniels Early Graduation Scholarship

The Mitch Daniels Early Graduation Scholarship application is now open. This scholarship was designed for high school juniors on track to graduate early. It offers a one-time award of \$4,000 and is available to students who graduate from a publicly supported high school at least one year ahead of schedule. The funds can be applied toward tuition and fees, with any remaining amount being disbursed to the student. It is important to note that the scholarship cannot be used for remedial coursework.
