# About Indiana Virtual

- Indiana Virtual School provides a high quality, technology-based education for students with specific life circumstances which require an alternative learning scenario.
  - Many INVS students enroll during their stay in one of the many Department of Child Services group homes or treatment facilities.
  - Others find the online nature and customized pacing a good fit for their particular life circumstances.
  - Additionally, most students who enroll in INVS are significantly credit deficient and not on track to graduate with their cohort.

# Test Results

Indiana Virtual School has contracted with Ivy Tech to provide testing locations across the state of Indiana. Attendance during these testing sessions has been significantly depressed as compared to enrollment which has had a detrimental impact on both the participation rate as well as the pass rate. Many students are not returning beyond the first day of testing while others do not show up at all.

# Growth & Improvement Data

## ELA

- 70 points for Top 75% Growth
- 79.2 points for Bottom 25% Growth.
- 74.6 points for Overall Growth

## MATH

- 52.5 points for Top 75% Growth
- 29.2 points for Bottom 25% Growth
- 40.9 points for Overall Growth





# Graduation Rate

- Most students who enroll in INVS are juniors or seniors who are significantly credit deficient and not on track to graduate with their cohort.
- The INVS on-time graduation rate for the 2015 cohort was 18.2%.

# Administrative Fees

- Daleville Community Schools received \$139,116.15 from Indiana Virtual School during 2015 for sponsorship monitoring.
- 100% of the money received was used to:
  - Pay the salary or portions of the salaries of the individuals responsible for monitoring INVS
  - Pay for monitoring equipment & services
  - Pay for contracted services to develop tools to better identify & assess the unique metrics presented by a virtual school
