INDIANA SCHOOL CHOICE SCHOLARSHIP PROGRAM HISTORY

The 2022-2023 Choice Scholarship Program Annual Report is the most up-to-date version of the report that was first released in January 2014. This version of the report reflects data from the 2021-2022 and 2022-2023 school years. Because some data will not be finalized until June, this information will not be available until the end of the school year and will be reflected in the 2023-2024 update of the Choice Scholarship Program Annual Report. Previously submitted Choice Scholarship Program Annual Reports can be found on the Choice Scholarship Program website.

Part of the Choice Scholarship Annual Report provides an overview of Indiana's Choice Scholarship Program that was passed into law as part of House Enrolled Act 1003-2011 (Public Law 92-2011). The Choice Scholarship Program provides Choice Scholarships to students who meet specific eligibility track and income criteria. Choice Scholarships are used to offset and assist with the cost of tuition and fees at participating Choice schools for eligible families.

The legal foundation for the Choice Scholarship Program can be found in IC 20-51 and 512 IAC 4, or by accessing information on the Choice Scholarship Program website.

ELIGIBILITY

Students must satisfy track and income eligibility requirements to participate in the Choice Scholarship Program.

STUDENT ELIGIBILITY CRITERIA

All students must satisfy the following two requirements:

- 1. Have legal settlement in Indiana; and
- 2. Be at least five years of age and less than 22 years of age on August 1st of the school year.

After satisfying the two requirements listed above, a student must satisfy the requirements for one of the eligibility tracks.

There were two eligibility tracks for the program's first year, 2011-2012 school year.

- 1. Two Semesters in Public School Track
 - a. The student was enrolled in first through 12th grade in a public school, including a charter school, in Indiana for at least two semesters immediately preceding the first semester for which the individual receives a Choice Scholarship;
 - b. Beginning with the 2013-2014 school year, kindergarten attendance could satisfy the two semesters in public school requirement; and
 - c. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the federal free or reduced price lunch program.
- 2. Previous Scholarship Granting Organization (SGO) Award Track
 - a. The student received an SGO Scholarship in a previous school year, including a school year that does not immediately precede the school year for which the student is applying for a Choice Scholarship. The eight currently certified Scholarship Granting Organizations (SGOs) are:
 - Community Foundation of Elkhart County

- Institute for Quality Education, Inc. (Formerly Educational Choice Charitable Trust)
- LaGrange County Community Foundation, Inc. (Participation ended February 2020)
- Professional Athletes of Indiana
- Sagamore Institute Scholarships for Education
- School Scholarship Granting Organization of Northeast Indiana, Inc.
- The Lutheran Scholarship Granting Organization of Indiana
- Tuition Assistance Fund of Southwestern Indiana (Closed February 2013); and
- b. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the federal free or reduced price lunch program.

For the 2012-2013 school year, a third track, the Previous Choice Scholarship Student Track, became applicable. The Previous Choice Scholarship Student Track was written into the original statute. However, because the 2011-2012 school year was the first year of the Choice Scholarship Program, no student could have met the criteria for this track prior to the 2012-2013 school year.

- 3. Previous Choice Scholarship Student Track (Previous Choice)
 - a. 2012-2013 School Year
 - The student received a Choice Scholarship in the previous school year.
 - b. 2013-2014 School Year
 - The student received a Choice Scholarship in a school year that does not immediately
 precede the school year for which the student is applying for a Choice Scholarship; or
 - The student received a Choice Scholarship in the immediately preceding school year, but the student exited the Choice school prior to the end of the school year.
 - c. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the federal free or reduced price lunch program.

For the 2013-2014 school year, legislative changes increased the number of eligibility tracks to seven.

- 4. Continuing Choice Scholarship Student Track (Continuing Choice)
 - a. The student received a Choice Scholarship in the school year that immediately precedes the school year for which the student is applying for a Choice Scholarship;
 - b. The student is required to have remained enrolled at the Choice school for the entirety of the immediately preceding school year; and
 - c. The student is a member of a household with an annual income equal to or below 200% of the amount to qualify for the federal free or reduced price lunch program.
- 5. Special Education Track
 - a. The student has a disability that requires special education services;
 - b. An individualized education program (IEP) pursuant to IC 20-35 or a service plan (SP) pursuant to 511 IAC 7-34 has been developed for the student; and
 - c. The student is a member of a household with an annual income equal to or below 200% of the amount to qualify for the federal free or reduced price lunch program.
- 6. "F" Public School Track
 - a. The student would be required to attend a specific public school based on his/her residence that has been assigned an "F" grade;
 - b. This track does not require prior attendance at the school; and
 - c. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the federal free or reduced price lunch program.

7. Sibling Track

- a. The sibling of the newly applying student received either a Choice Scholarship or an SGO scholarship in a preceding school year, including a school year that does not immediately precede the school year for which the student is applying for a Choice Scholarship;
- b. For purposes of the Choice Scholarship Program, the term "sibling" shall mean one of two or more individuals having one <u>or</u> both parents, guardians, or custodians in common. The term does not require a consanguineous (blood) relationship between the individuals; and
- c. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the federal free or reduced price lunch program.

For the 2017-2018 school year, legislative changes increased the number of eligibility tracks to eight.

8. Pre-K Track

- a. The student received and used an Early Education Grant under IC 12-17.2-7.2 to attend Pre-K at an eligible Choice school;
- b. The student is applying for a Choice Scholarship at the same Choice school where they attended Pre-K with an Early Education Grant; and
- c. The student is a member of a household with an annual income equal to or below 127% of the federal poverty level (69% of the amount to qualify for the federal free or reduced price lunch program).

For the 2021-2022 school year, legislative changes increased the number of tracks to nine but consolidated two to keep the number at eight.

9. Foster Track

- a. The student is placed in foster care, as defined in IC 31-0-2-46.7; and
- b. The student provides supporting documentation from a Department of Child Services (DCS) case worker.

For the 2021-2022 school year, legislative changes consolidated the Previous Choice Track and Continuing Choice Track. Now, only found under the Previous Choice Track, a student must have received a Choice Scholarship in any prior school year. Additionally, the household income limits for all eligibility tracks were raised to 300% of the amount to qualify for the federal free or reduced price lunch program.

INCOME ELIGIBILITY CRITERIA

The income criteria to participate in the Choice Scholarship Program for the 2022-2023 school year, shown in Table 1 below, are linked to the federal free or reduced price lunch program income guidelines.

The 90% award amounts are percentages of the tuition support amounts that the respective student's public school corporation of legal settlement would receive if the student enrolled in a public school in that corporation.

PARTICIPATION

STUDENT AND SCHOOL PARTICIPATION

Beginning with the 2019-2020 school year, a second Choice student application period was put in place. The original application, period one, is open from March 1 to September 1. The second application, period two, is open from November 1 to January 15. For purposes of the Annual Choice Report, a school is only counted as participating if they have one or more students receive payment, and students are only counted as participating if they receive a payment during the 2022-2023 school year.

The 2022-2023 school year saw the largest growth in the number of students since the 2014-2015 school year. Last year, the 2021-2022 Choice Scholarship Program had 43,559 participating students in period one, 817 participating students in period two, and 330 participating schools. The 2022-2023 school year saw an increase in participating schools to 343, the most participating schools of any year of the Choice Scholarship Program. There were 52,614 participating students in period one and 648 participating students in period two, which increased the total number of participating students for the 2022-2023 school year to 53,262. This also signified the first time since the inception of the second period application that the number of applicants has decreased.

The period two application was established, by law, to provide an opportunity for eligible Choice students to transfer to a new Choice school and receive a Choice Scholarship after the September 1 deadline. However, 648 students did not participate during period one and were new to participating in the 2022-2023 Choice Scholarship Program. Additionally, 78 participating students from period one participated in period two. Because these students were counted in the student count for period one, they were excluded from the period two count of 648, to avoid a duplicated count.

Table 3 illustrates the participating student applicant types for the 2022-2023 period two participating students. The table details whether a student participated in 2022-2023 period one, transferred schools, and participated for 2022-2023 period two; or if the student did not participate during 2022-2023 period one and participated for 2022-2023 period two and received only a period two Choice Scholarship award for the 2022-2023 school year.

Table 4, below, illustrates students that transferred during the 2022-2023 school year and participated in both application periods. The table shows students that participated during the first period application, left their original Choice school, and whether they returned to the same Choice school to apply and participate for the second period or enrolled, applied, and participated at a different Choice school for the second period. With 67 students changing schools from period one to period two, this means only 9.23% of period two participants and 0.13% of students are utilizing the period two application as it was intended.

Non-public schools, consisting of Choice and non-Choice schools, accounted for 7.83% of statewide student enrollment for the 2022-2023 school year. This is an increase of 0.38% from the 2021-2022 school year. Choice student enrollment increased by 0.79% over the same time period, which is only reflected by the period one count of 52,614. Overall state enrollment increased but traditional public and non-public (excluding Choice students) schools decreased in percentage. All other school types saw an increase in enrollment percentage.

PARTICIPATION BY GRADE LEVEL


The count of program participants by grade level, as well as the percent each grade level accounted for in terms of program participation each year, are detailed in Table 7. From the 2021-2022 school year to the 2022-2023 school year, no grade level increased or decreased by more than 0.85% as a percentage of participating students in the Choice Scholarship Program. The largest decrease, 0.25%, was found in the seventh grade. The largest increase, 0.85%, was found in the first grade.

The graph on the following page shows the marginal changes from the 2021-2022 school year to the 2022-2023 school year. The percentages for period one and total participants in both 2021-2022 and 2022-2023 are similar and with minimal change. The lines for period one and total are so closely aligned that they overlap, and an individual

line can hardly be seen in the graph. Both period two for 2021-2022 and 2022-2023 show no pattern or similarity to the other groups of data.

PARTICIPATION BY GENDER

Tables 8a and 8b provide data on the gender of participating Choice Scholarship students. In each year of the program, slightly more female students have participated than male students. Prior to this year, there has been a slight decrease each year in the number of female participating students and a slight increase in male participating students. The 2022-2023 school year has shown a slight increase in the percentage of female students and a slight decrease in male students. The changes in each year are marginal and female students still make up over 50% of the participating students in the Choice Scholarship Program. Overall, the percentages for male and female participating students are nearly 50% each. From the 2021-2022 school year to the 2022-2023 school year, there was a 0.10% increase in female students and 0.10% decrease in male students in total.



The graph on the next page depicts the percentage of participation by reported ethnicity of Choice Scholarship students. White ethnicity and Asian ethnicity were the only ethnicities that saw an increase from 2021-2022 to 2022-2023 with an increase of 3.02% and 0.16%, respectively. While Hispanic ethnicity and of any race makes up the second largest group of students, Hispanic ethnicity and of any race saw the largest decrease from 2021-2022 to 2022-2023 at 1.86%. All other ethnicities decreased by less than 0.95% each except for Native Hawaiian or Other Pacific Islander which stayed the same. While the ethnicities with the largest increase and decrease are the same as 2020-2021 to 2021-2022, the percentages of change are not as large. From 2020-2021 to 2021-2022 the white ethnicity increased by 4.06% and Hispanic ethnicity and of any race decreased by 2.66%.

The graph illustrates how closely the percentages for period one and the total are for both 2021-2022 and 2022-2023. Additionally, the graph illustrates how period two fluctuates from other illustrated periods.






PARTICIPATION BY GEOGRAPHIC AREA

Each public school corporation in Indiana is categorized as one of four geographic types – metropolitan, suburban, rural, or town. The geographic area for each student is determined by the public school corporation where the student lives. As illustrated in Table 10 on the next page, most students live in a metropolitan area. However, metropolitan areas saw the largest decrease from the 2021-2022 school year to the 2022-2023 school year at 2.93%. Meanwhile, suburban, rural, and town all experienced an increase from the 2021-2022 school year to the 2022-2023 school year of 2.37%, 0.51%, and 0.05% respectively.


PARTICIPATION BY TRACK

Table 11 depicts the track selected on Choice applications at the time the applications were submitted. A student can satisfy the eligibility criteria of more than one track, but only one can be selected at the time of application. As illustrated in Table 11 and the graph that follows, the majority of students participating in the 2022-2023 Choice Scholarship Program utilized the Previous Choice Track.

The Previous Choice Track is the most frequently used eligibility track in both number of students and percentage of participating students. However, Previous Choice Track saw a marginal percentage decrease from 2021-2022 to 2022-2023 of .04%. The Two Semesters, Special Education, F School, and Foster Tracks also saw a decrease of 1.23%, 1.17%, 0.95%, and 0.02%, respectively. However, due to legislative action, no accountability grades were issued to schools for the 2022-2023 school year which means that no public schools were assigned an "F" grade and the "F" School Track was unable to be utilized. Pre-K and Foster Tracks saw marginal increases of 0.05% and 0.13%, respectively, while the Sibling Track saw no change. The Previous SGO Track saw the largest increase, and overall change, from 2021-2022 to 2022-2023 at 3.35%. This is believed to be based on the legislative changes increasing the SGO income limits to 300% in 2021-2022 and more students being eligible to utilize an SGO and then able to utilize the Previous SGO Track for 2022-2023.

As can be seen in the graph below, the percentages for period one and total for 2021-2022 and 2022-2023 for all tracks besides the Sibling Track are consistent, while period two for both years show the opposite growth from the other periods. As stated above, the Two Semesters Track had the largest decrease year-over-year. Over half of participating period two students utilized the Two Semester Track. This number suggests that the students utilizing the second period application are students that are transferring from their 2022-2023 public school to a Choice school after the start of the school year.




There are two eligibility branches within the Sibling Track. A sibling of a student who received either a Choice Scholarship or an SGO award in a previous school year is eligible for the Sibling Track. As illustrated in Table 12 below and the graph on the next page, the majority, 59.22%, of students who applied under the Sibling Track were siblings of previous Choice Scholarship students. The actual number of students utilizing the Sibling Track due to a sibling receiving a Choice Scholarship decreased from 2021-2022 to 2022-2023. The use of the Sibling Track due to the sibling receiving a previous SGO award grew from 28.77% in 2021-2022 to 40.78% in 2022-2023. As stated on page 14, the income threshold increased in 2021-2022 for SGOs. This increase would permit more students to qualify for SGOs in 2021-2022 and then be able to utilize the Previous SGO Track in 2022-2023, as well as the sibling of the student that received the SGO through Sibling Track in 2022-2023.

PARTICIPATION BY PRIOR INDIANA PUBLIC SCHOOL ATTENDANCE



For the first time in the program's history, the percentage of students who previously attended an Indiana public school at any point in their educational history has increased. For the 2022-2023 school year, less than 37% of students participating in the Choice Scholarship Program have a record of previously attending an Indiana public school. While students can enter the Choice Scholarship Program through any one of the eight tracks, as more students without an attendance record in an Indiana public school use the Previous Choice Track, the number of students without an attendance record in an Indiana public school will most likely continue to grow.

The percentage change from 2021-2022 to 2022-2023 is consistent with prior years. The percentages for period one and total in 2021-2022 and 2022-2023 are comparable, while the percentages for period two for both years show the opposite of period one and total but are consistent from year to year. As stated on page 14, much like period two for 2021-2022, participation in 2022-2023 period two suggests that the students left their public school during 2022-2023 and enrolled and applied at a Choice school during the second period application window.

Of the 53,262 students participating in the 2022-2023 Choice Scholarship Program, 35,743 received a Choice Scholarship by applying under the Previous Choice Track. Of the other 17,519 students in the program, 4,640 applied under the Two Semesters in a Public School Track. Excluding the 84 students that used the Pre-K Track, the remaining 12,795 students applied under the Foster, Previous SGO, Sibling, and Special Education Tracks. The Foster, Previous SGO, Sibling, and Special Education Tracks do not require prior attendance in an Indiana public school.

Table 14 illustrates whether each student who applied under one of these tracks previously attended an Indiana public school at any point in their educational history. 2022-2023 period one and 2022-2023 total were very similar in percentages for both students that attended public school and those that did not. For these two different sets of data, Foster Track saw roughly a 2.37% decrease of students that never attended public school, Previous SGO Track saw roughly a 3.16% decrease of students that never attended public school, Sibling Track saw roughly a 2.15% decrease of students that never attended public school, and the Special Education Track saw roughly an 8.10% decrease of students that never attended public school. In previous reports the "F" School Track was listed in Table 14. However, as stated on page 14, this track was unable to be utilized in 2022-2023.

Overall, new Choice students using the tracks listed in Table 14 on the next page showed an increase of 2.48% in period one, a decrease of 1.77% in period two, and an increase of 2.14% in the percentage of students who have a record of attending an Indiana public school compared to the 2021-2022 school year.

SPECIAL EDUCATION

During the 2013 legislative session of the Indiana General Assembly, legislation was passed adding the Special Education Track and allowing non-public schools to be the designated special education service provider for eligible Choice Scholarship students. Choice schools that are selected as the special education service provider and agree to provide special education services to eligible Choice Scholarship students, may receive state special education funding for eligible Choice students. Prior to this legislation, non-public schools were not eligible to receive state special education funding for any eligible special education student.

At the time of application, the parent/guardian of a Choice student who qualifies to receive special education services must designate the Choice school or the public school corporation as the special education service provider. If the Choice school is selected as the special education service provider, the school is eligible to receive state special education funding for any eligible special education Choice student.


Table 15 and the graph on the following page detail the special education service provider selection of eligible Choice Scholarship students by their respective parent/guardian. For the 2022-2023 school year, 4,399 participating Choice Scholarship students were eligible for special education as reported on their Choice Scholarship application. Of these students, 758, or 17.23%, selected their Choice school as the special education service provider while the other 3,641, or 82.77%, selected the public school corporation where the Choice school is located if the Choice school is a physical location. If a Choice school is virtual, the public school corporation providing services would be the corporation where the student lives.

Compared to the 2021-2022 school year, 0.88% less applicable students chose the Choice school as the special education service provider in 2022-2023. Period one and total percentages for 2021-2022 and 2022-2023 were all between about 17% and 19% for Choice school and between 81% and 83% for the public school corporation. Period two showed much different percentages, coming in around 32% and 22%, for 2021-2022 and 2022-2023, respectively, of students selecting the Choice school as the special education service provider while 68% and 78%, for 2021-2022 and 2022-2023, respectively, selected the public school corporation.

For the 2022-2023 school year, 77 Choice schools were selected as the special education service provider for at least one eligible Choice Scholarship student, but only 71 of the schools received a payment for at least one student. The information shown in Table 16 shows the special education payment information for Choice schools for 2021-2022. In 2021-2022, Choice schools received a combined special education payment for eligible Choice students of \$1,967,336.23. In cases where a parent/guardian who designated the Choice school as the service

provider exited the Choice school prior to the end of the school year, a prorated refund of the special education funding was returned to IDOE.

RETENTION

PARTICIPANT RETENTION DURING THE SCHOOL YEAR

Participating Choice schools are required to report a Choice Scholarship student who withdraws from the Choice school to IDOE within five days of the student's exit date. Table 17 provides the count and percentage of participating students who exited a Choice school prior to the last day of school.

PARTICIPANT RETENTION BETWEEN SCHOOL YEARS

Table 18 on the next page illustrates participating student retention in the Choice Scholarship Program between school years. Of the 53,262 Choice Scholarship students who participated in the 2022-2023 Choice Scholarship Program, 36,354 of those students participated in the 2021-2022 school year. For the 2022-2023 school year, 35,743 students applied under the Previous Choice Scholarship Track. This means that 611 students were eligible for the Previous Choice Track in the 2022-2023 school year but utilized a different eligibility track on their respective applications.

AWARDS

CALCULATION OF AWARD AMOUNT

Currently, the value of the Choice Scholarship is the lesser of two amounts:

- 1) Tuition and fees charged to the student at the eligible Choice school; or
- 2) An amount based off the per-student state funding for the student's public school corporation of residence, determined as follows:
 - 90% of the funding formula amount if household income is up to 300% of federal free or reduced price lunch eligibility.

The 90% amount calculation, which uses the per-student state funding amount by the public school corporation of residence for the 2022-2023 school year, was posted on the <u>Choice website</u>. Currently, the 2023-2024 estimated award amounts can be found on the Choice website.


Beginning in the 2015-2016 school year, the maximum award amount of \$4,800 for grades one through eight was removed. Thus, the maximum award amount is the lesser of the tuition and fees charged to the student at the eligible Choice school or the 90% Choice Scholarship award amounts based on the funding formula.

AWARDS BY TYPE

The 2021-2022 school year was the first year of the Choice Scholarship Program to have only a 90% award type due to 70% and 50% award amounts being repealed. As stated previously in this report, the award amount for a student is the lesser of their respective Choice school's tuition and fees amount entered on the applying student's application or the 90% tuition support amount for the public school corporation of legal settlement entered on the applying student's application. Table 19 below shows the number of students that had tuition and fees as the lesser amount and the number of students that had the 90% amount as the lesser amount.


The graph below shows that the 90% award type increased 5.09% and the tuition and fees award type decreased by 5.09% from the 2021-2022 school year to the 2022-2023 school year. The graph also shows that the distribution of award types is not much different with 90% at 54.33% for 2022-2023 and tuition and fees at 45.67% for 2022-2023. This increase in 90% award amounts would indicate that more Choice Scholarship eligible families are now required to pay some of their tuition and fees since the Choice Scholarship award is less than the tuition and fees amount at their Choice school.



In addition to household income and household size, the Choice Scholarship Program utilizes the Choice Scholarship Eligibility System (CSES) and legal foster child status as verification that Choice students satisfy the income eligibility aspect of the application process. These two means of income verification are not required by law but have been implemented by IDOE to assist schools and families. The CSES is a database compiled of students who qualify for certain benefits from other state administered financial assistance programs. In addition, if a child has legal status as a foster child, the income eligibility criteria for the Choice Scholarship Program is satisfied. Students using CSES and foster child status are eligible if they meet the requirements for one of the eight tracks. The award amount for students using household size and income is dependent on their income and track. Table 20 below outlines the breakdown of students by the avenue in which they satisfied the income criteria.


The graph on the next page illustrates that the majority of students utilize household size and income to satisfy income eligibility with 82.28% of students.



Tables 21 and 22 below and on the following pages, outline the reported household sizes and incomes for the 82.28% of students who applied using household income and size for their income eligibility. Of those students, 89.39% live in a household with six or less people and 66.44% of these students live in a household with an annual household income of \$100,000 or less. The average household size and income for 2022-2023 total are 4.75 and \$81,817.52, respectively. This shows no change in the average household size from 2021-2022 to 2022-2023 and an increase in household income of \$13,617.69. The increase in income is likely due to the increase of the income guidelines to 300% of the free and reduced price lunch program. However, though the limit is 300%, a household size of 4.75 with an income of \$81,817.52 is roughly 159% of the free and reduced price lunch program for a household size of 4 and 136.20% for a household size of 5.

As shown in the graph below, the only household size types to increase from 2021-2022 to 2022-2023 were 4-6 and 13+ at 2.76% and 0.01%, respectively. The largest decrease from 2021-2022 to 2022-2023 came in household size type of 1-3 with roughly 1.73%.



As shown in Table 22 and the graph on the next page, only household income types \$0-\$50,000 and \$50,001-\$100,000 decreased for 2022-2023. The largest increase from 2021-2022 to 2022-2023 came in household income of \$100,001-\$150,000 at roughly 8.39%. The largest decrease from 2021-2022 to 2022-2023 came in household income of \$0-\$50,000 at roughly 9.30%. These changes in income type percentages are also likely due to the changes in the income guidelines to 300% for the federal free or reduced price lunch program.

AWARD AMOUNT BY TRACK

Table 23 details the total award amount of Choice Scholarship students by Choice Scholarship Track. As Table 11 on page 14 shows, the Previous Choice Track is the most commonly used track and receives the highest total award amount of all eight tracks. The award amounts shown are based on the qualified award amounts of each student, not the amount paid to the student. The amounts shown are the maximum that would be paid if every student remained enrolled for the full school year and did not receive a prorated award or have a refund owed. Additionally, 2022-2023 period two award amounts are calculated as half the award amount of 2022-2023 period one award amounts due to the Choice Scholarship only being used for half of the 2022-2023 school year. As stated previously, no public schools received an "F" grade due to legislation and the "F" School Track was unable to be utilized as a result.

AWARD AMOUNT BY GRADE

Table 24 below details the total award amount of Choice Scholarship students by grade level. In correlation with Table 7 on page 9, roughly the same distribution of total award amounts by grade can be seen in total participation by grade. Both tables illustrate the elementary school grade levels as having the most in count and amount. The amounts shown are the maximum that would be paid if every student remained enrolled for the full school year and did not receive a prorated award amount or have a refund owed, it is not the amount that has been paid. Additionally, 2022-2023 period two award amounts are calculated to half the award amount of 2022-2023 period one award amounts due to the Choice Scholarship only being used for half of the 2022-2023 school year.


AWARDS BY PUBLIC SCHOOL CORPORATION OF LEGAL SETTLEMENT

Table 25 provides the count of public school corporations where Choice students had legal settlement in the 2021-2022 and 2022-2023 school years. The Choice student count by public school corporation of legal settlement is provided in Appendix A. Please note that students may not have attended a public school in their public school corporation of legal settlement prior to participating in the Choice Scholarship Program. For 2022-2023 period two, no additional public school corporations were included that were not part of 2022-2023 period one. Overall, 2022-2023 Total saw an increase of 7 public school corporations from 2021-2022, or 2.63%.

Choice Scholarship students may apply for, and use, the award at any participating Choice school. Table 26 and the graph below show the count and percentage of Choice Scholarship students who used their award to attend a Choice school located inside or outside the boundaries of the student's public school corporation of legal settlement. For the 2022-2023 school year, about 59% of students attend a Choice school within the boundaries of their respective public school corporation of legal settlement. This is roughly a 1% decrease from 2021-2022. There is no evident reason why this data would change from the previous year. A list of Choice Scholarship student counts by participating Choice school is available in Appendix B.

Table 28 depicts the different amounts of tuition and fees charged to participating students. Roughly 76% of participating Choice students have a tuition and fee amount of \$5,001 to \$10,000. This is about a 9% increase from 2021-2022 to 2022-2023. All tuition and fee types besides \$0-\$5,000 saw a percentage increase from 2021-2022 to 2022-2023 with \$0-\$5,000 seeing a decrease of about 10.40%. This would indicate that Choice schools have increased their tuition and fees for 2022-2023.

Table 29 depicts the different payment scenarios for the 53,262 students who participated in the 2022-2023 Choice Scholarship Program. As also stated in Table 27, if all Choice students remained at their Choice school for the full year, the total amount that would be paid in Choice awards would be \$311,814,031.70. Based on the reported tuition and fees for those same students at their respective Choice school, the full tuition and fees for all participating Choice students would total \$381,654,268.05 for the 2022-2023 school year. Since 24,327 students received an award amount equal to their reported tuition and fees amount, that leaves \$69,840,236.35 in tuition and fees to be paid by the families of the 28,935 students who did not receive their full tuition and fees as their award amount, averaging \$2,413.69 due to Choice schools per student. Additionally, if the same 53,262 Choice students were to attend their public school corporation of legal settlement for the 2022-2023 school year, the amount that would be paid in public tuition support would total \$376,588,483.12. Three caveats made in Table 29 are that \$311,814,031.70 would be paid due to no students withdrawing early, \$381,654,268.05 is the full tuition that Choice schools would charge students in both 2022-2023 period one and 2022-2023 period two, and that if all Choice students were not enrolled at a Choice school, they would enroll at their respective public school corporation even though data indicates that a majority of Choice students have never attended a public school.

CHOICE SCHOLARSHIP PAYMENTS

Choice Scholarship award payments are made to the Choice school on the student's behalf at least once each semester. The student (if 18 years of age or older) or the student's parent or guardian signs an Endorsement Form authorizing IDOE to disburse the Choice Scholarship funds directly to the participating Choice school on behalf of the Choice student.

IC 20-51-4-6 specifies, (a) If an eligible Choice Scholarship student enrolls in an eligible school for less than an entire school year, the Choice Scholarship provided under this chapter for that school year shall be reduced on a prorated basis to reflect the shorter school term.

The payment and prorated refund amounts for the 2021-2022 Choice Scholarship Program are detailed in Table 30. The information for the 2022-2023 school year will not be available until the end of the 2022-2023 school year and the data will not be published until the 2023-2024 version of the Choice Scholarship Program Annual Report.

2022-2023 Choice Student Summary
