Participating LEAs (Indiana public school corporations, charter and state schools) receive and retain 100% of joint-funded (state/federal) Medicaid reimbursements for covered medical services, and restore the state-funded portion to state tuition support. IDOE performs the Medicaid Adjustment to account for state education funds included in these joint-funded payments; and LEAs may use their unrestricted federal Medicaid funds (typically about 66% of total Medicaid payments) as they choose, for example, to cover costs of specialized equipment, training, supplies, and professional development.
