Choice Scholarship Program Track Eligibility Requirements 2022-2023 School Year

What are the student eligibility criteria?

To be eligible, a student must satisfy each of the following requirements:

- a. Have legal settlement in Indiana;
- b. Is at least five years of age and less than 22 years of age on August 1 of the school year;
- c. Meets at least one of the eight eligibility tracks listed below; and
- d. Is a member of a household with an annual income of not more than 300% of the amount required for the individual to qualify for the federal free or reduced price lunch program.

After satisfying the requirements listed above, there are eight different tracks that enable a student to be eligible to participate in the Choice Scholarship Program. The eight tracks are outlined below. A student must satisfy the requirements of only one of the eight tracks to be eligible. Previous Choice Scholarship Student Track

- i. The student received a Choice Scholarship in a preceding school year, including a school year that does not immediately precede the school year for which the student is applying for a Choice Scholarship.

Previous Scholarship Granting Organization (SGO) Award Track

- i. The student received an SGO Scholarship in a previous school year, including a school year that does not immediately precede the school year for which the student is applying for a Choice Scholarship. The approved Scholarship Granting Organizations (SGOs) are:
 - Community Foundation of Elkhart County
 - Institute for Quality Education, Inc. (Formerly Educational Choice Charitable Trust)
 - LaGrange County Community Foundation, Inc. (no longer participating, effective January, 2020)
 - Professional Athletes of Indiana
 - Sagamore Institute Scholarships for Education Choice
 - School Scholarship Granting Organization of Northeast Indiana
 - The Lutheran Scholarship Granting Organization of Indiana
 - Tuition Assistance Fund of Southwestern Indiana (Closed February 2013)

Special Education Track

- i. The student has a disability that requires special education services;
- ii. An Individualized Education Plan (IEP) has been developed for the student under IC 20-35 or a Service Plan (SP) has been developed under 511 IAC 7-34.

"F" Public School Track

- i. The student would be required to attend a specific public school based on his/her residence that has been assigned an "F" grade. The list of "F" schools for Choice Scholarship eligibility is posted prior to the beginning of the school year.

Two Semesters in a Public School Track

- i. The student was enrolled in kindergarten through grade 12 in a public school, including a charter school, in Indiana for at least two semesters immediately preceding the first semester for which the individual receives a Choice Scholarship.

Sibling Track

- i. The sibling of the newly applying student received either a Choice Scholarship or an SGO Scholarship in a previous school year, including a school year that does not immediately precede the school year for which the student is applying for a Choice Scholarship.

Pre-K Track

- i. The student received and used an Early Education Grant under IC 12-17.2-7.2 to attend pre-K at an eligible Choice school; and
- ii. The student is applying for a Choice Scholarship at the same Choice school in which they attended pre-K with an Early Education Grant.

Foster Track

- i. A student must be placed in foster care, as defined in IC 31-9-2-46.7. The child's placement must be supported by a letter from a Department of Child Services (DCS) case worker that is signed and dated during the 2022 calendar year.
- ii. Foster children are automatically income eligible for the Choice Scholarship Program and do not require household size and income. Supporting documentation of foster care must be provided at the time of application.

Clarifications

- Currently, the only Early Education Grant that satisfies the requirements is On My Way Pre-K.
- The "F" Public School Track does not require prior attendance at the school.
- For purposes of the Choice Scholarship Program, the term "sibling" means students who share at least one parent, legal guardian, or legal custodian. The term does not require a consanguineous (blood) relationship between the individuals.
- To be eligible under the Sibling Track, the student's sibling must have received a Choice Scholarship or SGO award in a previous school year.
- An SGO award must be at least five hundred dollars (\$500) in order for a student, or the student's sibling, to qualify later for a Choice Scholarship under the Previous SGO Track. This rule only applies to a student or a sibling of the student who receives an SGO award for the first time after June 30, 2013, and otherwise meets the income eligibility requirements of the program.
- A student is considered to have attended a public school for a full semester if the student is enrolled in a public school on or before the applicable Average Daily Membership (ADM) count day through the end of the semester.



Choice Scholarship Program Requisitos de Elegibilidad de Track Año Escolar 2022-2023

¿Cuáles son los requisitos de elegibilidad para el estudiante?

Para ser elegible, el estudiante debe de satisfacer cada una de los siguientes requisitos:

1. Residir en Indiana
2. Tener entre 5 a 22 años a más tardar el 1ro de Agosto del año escolar

Después de satisfacer los requisitos listados arriba, hay ocho caminos (tracks) distintos que permiten al el estudiante ser elegible para participar en el Programa de Becas Choice. Los ocho distintos caminos, marcados del 1 al 8, están resumidos abajo. El estudiante debe satisfacer los requisitos de solo uno de los ocho caminos para ser elegible. Previo Choice Scholarship Student Track – Cualquiera de los puntos 1 o 2

- i. El estudiante debe Haber recibido una beca Choice en un año escolar que no precede inmediatamente al año escolar para el cual el estudiante está solicitando la beca Choice;

Previo Scholarship Granting Organization (SGO) Award Track

- i. El estudiante debe de haber recibido una Beca SGO en un año escolar anterior, incluyendo un año escolar que no precede inmediatamente al año escolar para el cual el estudiante está solicitando una Beca Choice. Las siguientes son organizaciones aprobadas de Scholarship Granting (SGO's):
 - Community Foundation of Elkhart County
 - Institute for Quality Education, Inc. (Formerly Educational Choice Charitable Trust)
 - LaGrange County Community Foundation, Inc.
 - Professional Athletes of Indiana
 - Sagamore Institute Scholarships for Education Choice
 - School Scholarship Granting Organization of Northeast Indiana
 - The Lutheran Scholarship Granting Organization of Indiana
 - Tuition Assistance Fund of Southwestern Indiana (Closed February 2013)

Special Education Track

- i. El estudiante debe tener unas discapacidad que requiere servicios de educación especial;
- ii. Tener un Plan de Educación Individualizada (IEP) conforme a IC 20-35 o un plan de servicio(SP) conforme a 511 IAC 7-34 ha sido desarrollado para el estudiante; y

"F" Public School Track

- i. El estudiante debe ser requerido para asistir a una escuela pública especificada basada en su residencia que se le ha asignado una calificación de "F". La lista de elegibilidad de escuelas con F para la Beca Choice está fijada antes del principio del año escolar. Nota: Este camino (track) no requiere asistencia previa a la escuela.
