

Early Literacy Endorsement Verified Professional Development Programs

Indiana Code (IC) 20-28-5-19.7 requires current Indiana educators who teach in a content area that involves literacy instruction for PK-5 students to complete the Early Literacy Endorsement for license renewal. Per statute, the 80 hours of professional development needed to support an educator's application for the Early Literacy Endorsement must meet the requirements outlined in the table below.

The training providers outlined below may be used to fully or partially meet these requirements. To be added to this document or to update existing information, training providers must complete <u>this form</u> for IDOE review and consideration. This list will continue to be updated.

Early Literacy Endorsement Professional Development Requirements

Educators adding the Early Literacy Endorsement must complete eighty (80) hours of evidence-based professional development that:

- A. Aligns with science of reading
- B. (1) Is accredited by the International Dyslexia Association, or
 - (2) Aligns with Knowledge and Practice Standards for Teachers of Reading (KPS) as determined by IDOE, or
 - (3) Is approved by IDOE
- C. Is individualized and provides on demand support.
- D. Promotes explicit, systematic, and cumulative instruction as the primary approach to literacy instruction;
- E. Aligns with both:
 - 1. word recognition (at least 25 hours) and
 - 2. language comprehension (at least 25 hours);
- F. Promotes an understanding of how language, reading, and writing relate to each other;
- G. Promotes strategies for differentiated instruction for: (A) students with: (i) reading difficulties; or (ii) disabilities; and (B) English learners;
- H. Focuses on (1) phonemic awareness, (2) phonics, (3) fluency, (4) vocabulary, and (5) comprehension;
- Allows participants to implement the strategies into a classroom environment with the opportunity for feedback throughout the professional development experience;
