What data was to be collected?

In compliance with Indiana Code (IC) 20-19-3-27.5 and IC 20-26-5-42, the Indiana Department of Education (IDOE) collected the following data from public schools regarding school employees who were physically injured while on the job by a student of the school. Per statute, during the 2024-2025 school year, there were three incident types collected, in addition to the total number of unique incidents. This includes:

1. The number of incidents where a school employee's injury was required to be reported to the public school's worker's compensation carrier;
2. The number of incidents where a school employee's injury caused them to miss all or part of one or more work days;
3. The number of incidents where a school employee's injury was required to be reported to the public school pursuant to the school's reporting policy; and
4. The total number of unique employee injury incidents involving one or more of the above incident types.

How was the data collected?

Per IC 20-26-5-42, each public school shall provide the above data to IDOE annually. Indiana Code does not provide IDOE with statutory enforcement authority to ensure reporting compliance. For the 2024-2025 school year, schools submitted the required data through Data Exchange during the final reporting window. This reporting window ended on July 15, 2025. The chart beginning on the following page is a complete list of schools that reported one or more school employee injury incidents.

**Note Columns 1-3 are not mutually exclusive, thus, columns 1-3 may add up to a number greater than column 4. For example, a single incident may have been reported to the school's worker's compensation carrier and resulted in an employee missing work. Column 4 is intended to understand the number of overall unique incidents reported by a school corporation.*
