## **Educator Pipeline (Attract, Prepare, Retain)** Aspiring Statewide Special Education Teacher (ASSET) Cohort Four Application Now Available

Applications for cohort four of ASSET are now available. ASSET is an approved alternative licensure program delivered by the Indiana Council of Administrators of Special Education (I-CASE) for currently-licensed Indiana teachers to add a special

education teaching credential. Completing the program and passing the licensing exam allows educators to add Mild Interventions, Intense Interventions, or both to their existing credentials. ### Employability Skills Standards: Public Comment Opens Monday, February 24 Pursuant to Indiana Code (IC) 20-31-3-3, IDOE convened committees representing K-12 and higher education entities, state

agencies, and industry and community partners to review and propose updates to the K-12 Employability Skills Standards. The standards are grade banded and organized to reflect alignment with Indiana's Graduates Prepared to Succeed (GPS) characteristics and skills or traits as outlined in Indiana's Postsecondary Study. IDOE welcomes constructive, actionable feedback related to these standards during a <u>public comment period</u> beginning Monday, February 24, through Friday, March 14, to further inform the review process.
