<p><b>Understanding I AM Webinar Available</b> The Understanding I AM Webinar provides an overview of the I AM assessment on the Indiana Assessment Portal.</p>	By Monday, October 7
<p><b>Test Information Distribution Engine (TIDE) Refresh</b> Corporations and non-public schools must ensure enrollment and demographic data is correct in their student information system (SIS). The Indiana Department of Education (IDOE) will include SIS updates via nightly Data Exchange. Student enrollment and accommodations data also begin populating within <a href="#">TIDE</a> via IDOE nightly file transfer or Data Exchange.</p>	Monday, August 12*
<p><b>Registration Opens: First Year I AM Test Administrator (TA) Training</b> Registration opens for the First Year I AM TA Training via the Indiana Assessment Portal. This live training webinar covers I AM administration and is required for all new I AM TAs.</p>	Monday, December 9
<p><b>Regular Print, Large Print, and Braille Accommodated Materials Initial Orders Deadline</b> Regular print, large print, and braille accommodations must be noted in the student's Individualized Education Program (IEP) by Friday, December 13. Only one grade-level set of paper materials will be shipped per school rather than per student.</p>	Friday, December 13
<p><b>I AM TA Certification Course Deploys</b> This online course and certification quiz is required for all I AM TAs, and is separate from the ILEARN and IREAD certification training. TAs administering I AM and ILEARN and/or IREAD must complete both online courses, and completion will be indicated in TIDE.</p>	By January 13, 2025
<p><b>Released Items Repository (RIR)</b> Released items for I AM are continuously available in the <a href="#">RIR</a> on the <a href="#">Indiana Assessment Portal</a>.</p>	<i>Continuously Available</i>

<p><b>Braille Accommodated Materials Additional Order Window</b> Schools must submit orders within TIDE for braille test booklets for students with a new or updated accommodation after Friday, December 13. Braille forms cannot be ordered after January 10, 2025.</p>	December 18, 2024 - January 10, 2025
<p><b>Spring Pretest Workshop Available in Moodle</b> The Spring Pretest Workshop requires completion by the Corporation Test Coordinator (CTC) prior to testing. CTCs should train staff using information accordingly.</p>	February 7, 2025
<p><b>I AM Question and Answer (Q&amp;A) Session Registration</b> IDOE will host two Q&amp;A sessions to address any questions regarding I AM administration prior to the assessment window.</p>	February 3, 2025
<p><b>I AM Test Administrator's Manual (TAM) Available</b> The I AM TAM will be available on the Indiana Assessment Portal. This document details how to successfully administer I AM assessments.</p>	By February 17, 2025
<p><b>First Year I AM TA Training</b> The live training webinar for new I AM TAs will cover critical aspects of administering I AM and is required for all first year TAs.</p>	February 12, 2025, 3 to 4 p.m. ET
<p><b>I AM Q&amp;A Sessions</b> IDOE will host two Q&amp;A sessions for educators to address questions regarding the administration of I AM prior to the operational testing window. <p><b>Additional Order Window: Accommodated Materials</b> Additional print and large print materials may be ordered for students not indicated during the initial window. <b>Invalidation and Discrepancy Resolution Window</b> Schools should invalidate any tests in TIDE as necessary.	April 2 - May 23, 2025
<b>I AM Participation Reports Deploy</b> Test Coordinators and TAs can track test administration progress within TIDE.	April 2, 2025
<b>After Testing</b>	
<b>Preliminary Student Results Available in the Centralized Reporting System (CRS)</b> Corporations and schools can begin accessing preliminary student results in CRS.	April 7, 2025
<b>Final Student Results Available in CRS</b> Individual students results are available in CRS. Final reports may be downloaded in several formats. No printed copies of Individual Student Reports (ISRs) or student score labels will be shipped to schools.	July 1, 2025

Indiana's Alternate Measure (I AM) measures student achievement and growth according to Indiana's Content Connectors aligned to the Indiana Academic Standards. I AM is the summative accountability assessment for students with significant cognitive disabilities in grades 3-8 and high school. It assesses English/Language Arts (grades 3-8 and 10), Mathematics (grades 3-8 and 10), Science (grades 4, 6, and Biology), and Social Studies (grade 5).
