Indiana's Alternate Measure (IAM) measures student achievement and growth according to Indiana's Content Connectors aligned to the Indiana Academic Standards. I AM is the summative accountability assessment for students with significant cognitive disabilities in grades 3-8 and high school. It assesses English/Language Arts (grades 3-8 and 10), Mathematics (grades 3-8 and 10), Science (grades 4, 6, and Biology), and Social Studies (grade 5).
