INTRODUCTION

Indiana's Results Driven Accountability (RDA) System is utilized to ensure local education agencies (LEAs) are implementing the requirements of Individuals with Disabilities Education Act (IDEA). This includes the analysis of data related to the 17 Indicators defined by Office of Special Education Programs (OSEP) and reported in the State Performance Plan/Annual Performance Report. Each local educational agency (LEA) receives an annual determination indicating the level of compliance and the level of support necessary to address performance. Based on a LEA's score on several criteria, the LEA is ranked in one of three categories of determination:

- Meets Requirements;
- Needs Assistance; or
- Needs Intervention

The Indiana Department of Education's (IDOE's) Office of Special Education (OSE) fulfills this responsibility through the RDA monitoring process. The RDA includes three elements:

- Results (including federal results indicators and other assessment data)
- Compliance
- Timely Data

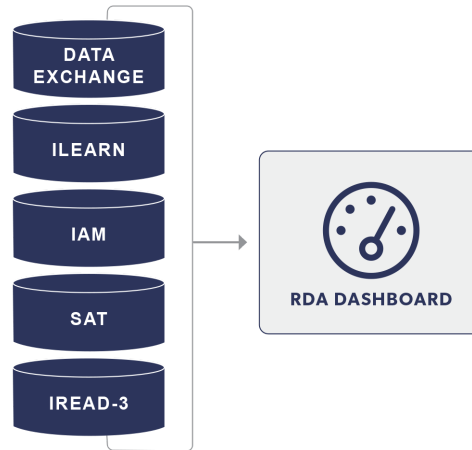
Purpose of the RDA Dashboard

The RDA dashboard is a web-based application located in the IDOE Link Portal. LEAs utilize it to assist with collecting and managing data for the multiple indicators monitored by OSE as required by IDEA. Districts will utilize the RDA dashboard to improve the way data and information are shared with OSE. This includes:

- Greater transparency at the state and local levels for all the elements and indicators tracked through the RDA process.
- More efficient and effective reporting system for LEAs. The dashboard serves as a hub for all LEA performance measures and allows both OSE and LEAs to view changes over time and identify successes and areas that need improvement.
- A systematic method to help OSE leverage performance data to effectively plan for professional development and further technical assistance opportunities in support of improving outcomes for students with disabilities.

RDA Data Sources

All data in the RDA dashboard is submitted by each LEA to IDOE through the completion of state assessments or through Data Exchange:



User Roles

The RDA dashboard can be accessed by authenticated LEA administrators. LEA administrators have access to their individual LEA data. They can view the following information in the RDA:

Data Viewer role

A person that is assigned "Data Viewer" is part of an educational organization such as a cooperative or interlocal which is known within the LINK portal as being in a network. This person should have access to data for all the member LEAs/schools of that network. This user should see the RDA data for **all** of the LEAs/schools within that network.

This user type will see in the top ribbon of the dashboard on the Summary Dashboard, Results Index, Compliance Index, and Timely Data Submissions tabs a dropdown list of LEAs the user has access to. Below is a screenshot of the dropdown. In the screenshot below the LEAs for the state are shown in alphanumeric order; however, users will only have access to the LEAs within their network.

DOE Data Viewer role

A person that is assigned "DOE Data Viewer" is an IDOE staff member and will have access to data for all LEAs in the state of Indiana.

DOE Data Administrator

DOE Data Administrator is an internal administrator role. A person that is assigned the "DOE Data Administrator" role will have access to data for all LEAs in the state of Indiana. Apart from viewing the data, the user will have additional privileges to configure the dashboard access, user roles for other users.

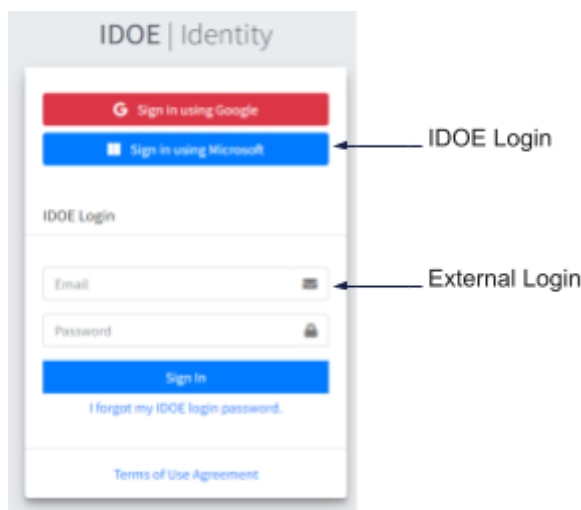
LEA Administrator

A LEA representative assigned as "LEA Administrator" for an LEA, should have access to data of specific LEAs assigned.

NAVIGATING THE RDA DASHBOARD

Access the RDA Dashboard

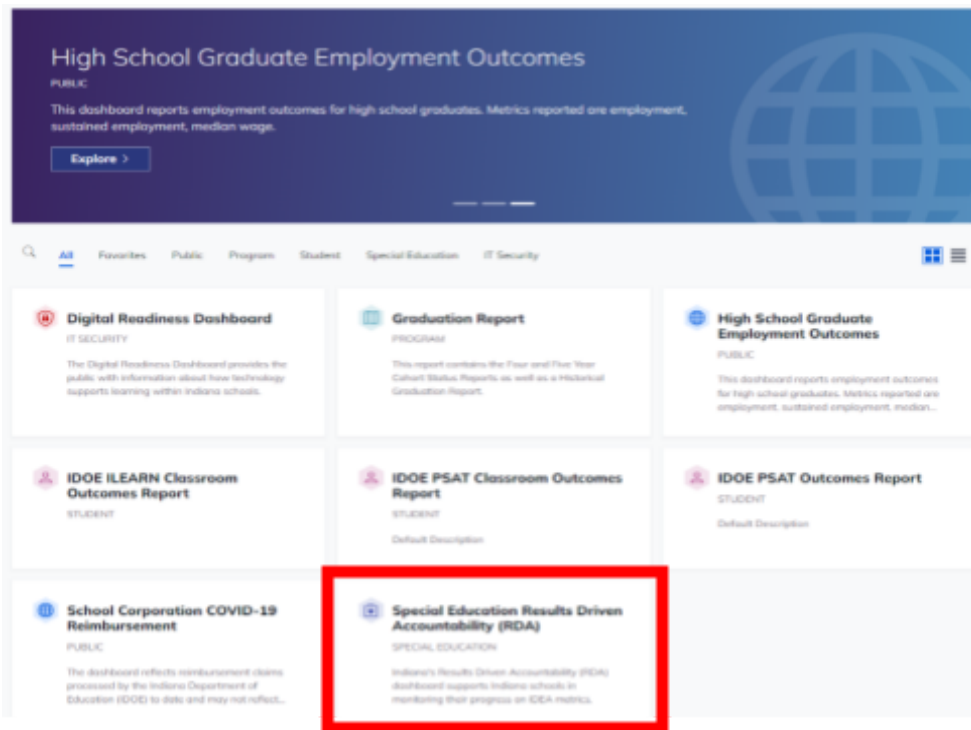
1. Users can access the RDA dashboard via the IDOE Link Portal. Users login to the LINK portal at the IDOE Link Portal which is the single sign-on portal for all applications. User login from the IDOE Access to the RDA dashboard must be granted by the assigned designee at a school corporation. School corporations are responsible for assigning correct roles in the IDOE Link Portal.



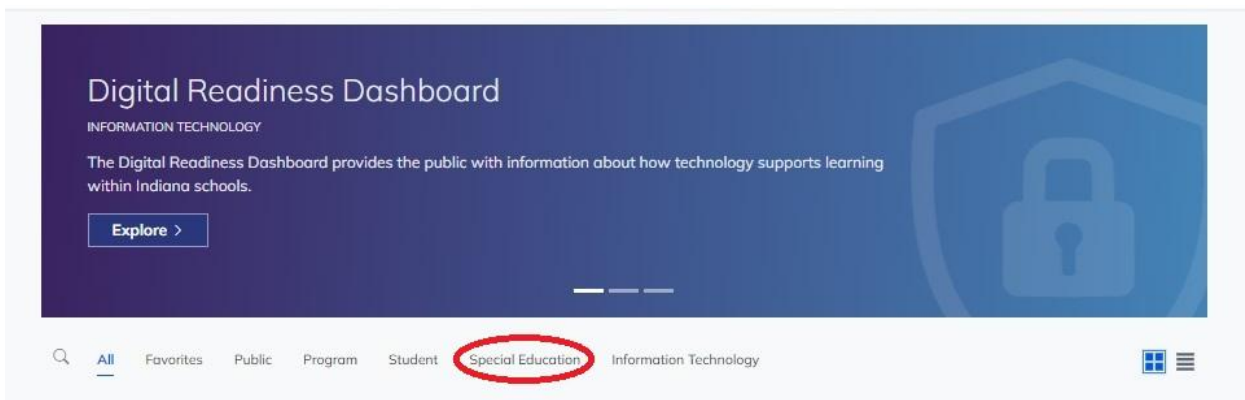
2. Based on role, users are presented with applications in the IDOE Link Portal. EdData is available to all users.



3. Select the “Special Education Results Driven Accountability (RDA)” dashboard. Some users may see more than one dashboard within EdData. To easily access the dashboard, click on the Special Education tab in the ribbon near the top of the EdData screen.

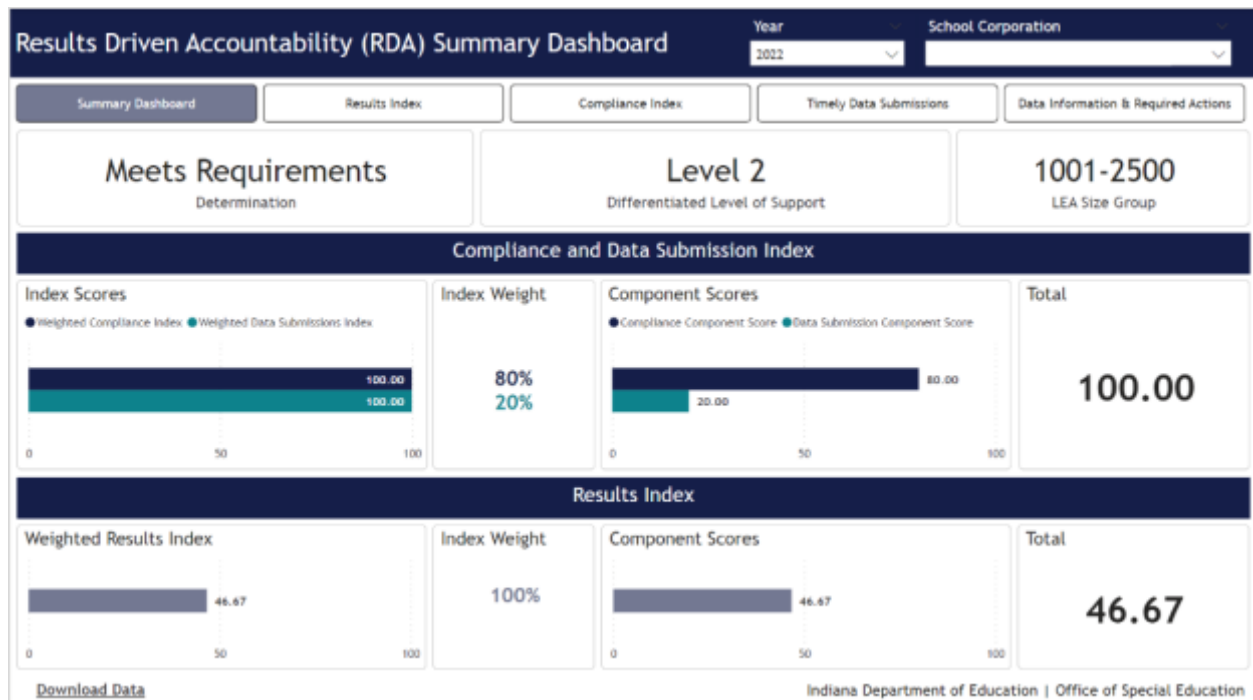
RDA Dashboard Tabs

Summary Dashboard

Displays the LEA's Compliance and Data Index Totals and Results Index Total. The school corporation slicer is a single select filter that allows a user to view the data for a selected LEA.



Results Index

Displays the results scores and rates for each indicator with the summation and weighted summation at the top.



Compliance Index Tab

Displays the compliance status and score for each indicator along with any indication of continuing or longstanding noncompliance. The scores are summed at the top of the page along with the weighted total.

1. Open the RDA dashboard.
2. To export the data, select a visualization.
3. Select the **Download Data** hyperlink in the bottom, left corner.
4. Select the table. Click on the ellipses in the top right corner. Select **Export Data**.

5. Select the desired data download format, then Export.
Note: The “Dashboard with current layout” and “Summarized data” formats can be saved as an Excel spreadsheet or CSV file.
6. A **CSV** or **Excel** file containing your data will download to the default location on your device (e.g., *Downloads* folder).
7. Open the file, then select **File>Save As**.
8. Select a location for the CSV file and select **Save**.

Differentiated Level of Support	"Level 1" if in the top 75th percentile of results score, "Level 2" if above the fifth to 25th percentile of results score, and "Level 3" if in fifth percentile or below.

SCORING OVERVIEW

SUMMARY DASHBOARD

- Compliance and Data Submissions Index Total = (Weighted Compliance Index x 0.8) + (Weighted Data Submissions Index x 0.2)
- Results Index Total = Weighted Index for Results
- Determination = "Meets Requirements" if above the 25th percentile of the compliance and data submission scores among all school corporations, "Needs Assistance" if above fifth to 25th percentile of the compliance and data submission score, and "Needs Intervention" if in fifth percentile or below. Note: If the school corporation is in the 10th percentile or below on the results index score, the highest determination they can get is "Needs Assistance."
- Differentiated Level of Support = "Level 1" if above the 25th percentile of results score, "Level 2" if above the fifth percentile up to 25th percentile of results score, and "Level 3" if in fifth percentile or below.

 - DOE Special Education (DOE-SE) Score x 3.6
 - DOE Special Education Evaluation (DOE-EV) Score x 3.6
 - DOE Special Education Terminations and DOE Graduates (DOE-TR/GR) Score x 3.6
 - Related SPED reporting Score x 3.6

 - ii. DOE Homebound/Hospitalized
 - iii. DOE Non-Certified Employees
 - iv. DOE Calendar and Certification of Instructional Days
