- Summer EBT Discontinued The Summer EBT (SUN Bucks) program will be discontinued in 2025. As part of National School Lunch Program (NSLP) requirements,

schools are required to advertise the availability of meals through the SUN Nutrition meals programs. Sponsors that serve meals at open sites on the Summer Food Service Program (SFSP) or Seamless Summer Option (SSO) should advertise their meal locations. Sponsors that do not participate in summer meal service must notify families that meals may be available in the community. Sponsors can provide

- Community Eligibility Provision (CEP) Election Period Now through Monday, June 30 The 2025-2026 school year (SY) CEP election period is open until Monday, June 30. CEP allows high-poverty schools to provide breakfast
- and lunch free to all students. CEP reduces the district's paperwork and school meal administrative costs by streamlining the meal application process. A school district may implement community eligibility in any school or group of schools with an enrollment minimum

of 25% or more students that are directly certified for free meals (identified students). Determination of eligibility must be made by local school corporations by using direct certification and enrollment data collected annually in

April. The application deadline to participate in CEP for SY 2025-2026 is Monday, June 30. Upon submission of the requested information, a validation process will take place prior to final approval. Fiscal Year (FY) 2024 NSLP Equipment Assistance Grant Applications Due Friday, May 16 Applications for the 2024 National School Lunch Equipment Grant are being accepted until Friday, May 16. Indiana has received \$229,328 from USDA to award Equipment Assistance Grants for FY 2024 (this award is always one year behind the current program year). Public school districts, private schools, and residential child care institutions (RCCI) are eligible to apply if they participate in the NSLP. Priority will be given to schools where at least 50% of the students are eligible for free or reduced-price meals and have not previously received an

3. SFAs should make every effort to utilize their inventory by drawing down pounds as close to zero at the processing companies by Monday, June 30. Any remaining unused pounds will carry over to school year 2025-2026 unless needed to assist other

4. The last day to place a produce order in FFAVORS for school year 2024-2025 is Tuesday, June 24. Schools must enter their Department of Defense (DoD) Program receipts into the Fresh Fruits and Vegetables Order Receipt System (FFAVORS) within

1. USDA Foods direct delivery (brown box) allocations have now ended as of Wednesday, April 30.

- two calendar days after the produce is delivered to your school. All USDA DoD receipts must be entered into (FFAVORS) by Monday, June 30, or before leaving for summer break. All DoD funds must be used by Monday, June 30. Any unused funds do not carry over to the next school year and will be lost.

Artificial Intelligence (AI) Policy IDOE recently released SCN 2025-01: The Use of Artificial Intelligence policy. This newly released policy provides guidance for program operators using AI with child nutrition programs. SFAs might choose to use AI to develop menus, participate in nutrition-related

meetings or administrative reviews, maintain recordkeeping requirements, etc. The policy outlines considerations and requirements

Updated Adult Meal Pricing Guidance

USDA Regulations 7 CFR 210.21(d)(8) and 7 CFR 220.16(d)(8) allow for temporary accommodation for the upcoming SY 2025-2026 thresholds. The accommodation process provides the IDOE the ability to approve temporary relief for school food authorities (SFAs) that demonstrate they cannot meet the thresholds for non-domestic food purchases established in 7 CFR 210.21(d)(5) and 7 CFR

ISNL is intended for new school nutrition program directors and provides an overview of school nutrition programs, defines the role and responsibilities of a director, and reviews the relationship between local policies and state/federal regulations.

Reminders

Breakfast and lunch served to adults under the School Nutrition Programs must be priced so that the adult payment is sufficient to cover the overall cost of the meal, including the value of any USDA entitlement and bonus donated foods used to prepare the meal. Beginning SY 2025-2026, SFAs are allowed to use the previous school year's reimbursement rates to set adult meal pricing for the following year if pricing was approved by the school board (or equivalent) prior to the newest reimbursement rates being released. If adult pricing has not been reviewed and board approved until after the new school year's reimbursement rates are released, then the newer rates should be used when determining the adult meal price.

On April 25, 2024, the USDA Food and Nutrition Services (FNS) published the final rule, Child Nutrition Programs: Meal Patterns Consistent With the 2020-2025 Dietary Guidelines for Americans (89 FR 31962, April 25, 2024). Among other provisions, this rule finalizes regulations that strengthen the School Meal Programs' Buy American provision. In the final rule, USDA established a new threshold for SFAs that use exceptions for the Buy American provision in regulation. The limit on the percent of total commercial food costs from nondomestic foods will be phased in over seven school years as follows: Beginning in SY 2025-2026, the nondomestic food purchases cap will be 10%*.
