

The Indiana Department of Education (IDOE) obtains input from Local Education Agencies (LEAs) regarding the use of these funds through discussions with the Executive Committee of the Indiana Council of Administrators of Special Education (ICASE). Additional discussions were held with members of the State Advisory Council on the Education of Children with Disabilities. Members of the Council include parents of students with disabilities, agencies involved in services to children, and LEA representatives. The application and Interactive Spreadsheet are posted on the IDOE website to allow public comments to be submitted to the IDOE

Explanation of the availability of a free appropriate public education to parentally placed nonpublic school students with disabilities

In order to determine the student's eligibility for special education and related services, a parentally placed nonpublic school student may request an evaluation from the LEA in which the nonpublic school is located or the LEA in which the student resides. The LEA in which the nonpublic school is located, before evaluating a nonpublic school student that does not otherwise reside in the LEA, must explain the concept of a free appropriate education and that the student has a right to obtain an offer of a free appropriate public education from the LEA in which the student resides. The parent is free to choose either LEA to conduct the evaluation.

Special education services are available to all parentally placed nonpublic school students with disabilities

Parentally placed nonpublic school students with disabilities are not entitled to the full array of special education and related services that an LEA would make available to the student if the student were enrolled in the public school. However, Article 7 requires that the LEA in which the nonpublic school is located offer some level of special education and related services to all eligible nonpublic school students.

Parentally placed nonpublic school students with disabilities may be eligible for an Education Scholarship Account (ESA), under Indiana Code 20-51.4. Indiana Education Scholarship Account is administered by the Indiana Treasurer of State. Under IC 20-51.4, the parent may use state funds in the account to pay for special education and related. The parent may choose to have special education funds added to the ESA so that the parent may choose which services to provide and the service providers to provide those services pursuant to an education scholarship account education service plan (ESA-SP). Article 7 prescribes the process by which a student's public school of residence works with a parent to develop the ESA-SP.

Home Instruction or alternative setting services

When the case conference committee determines that a student will receive special education and related services in a student's home or alternative setting, the case conference committee must convene at least every 60 instructional days to review the student's individualized education program (IEP). The case conference committee determines the type, length, frequency, and duration of special education and related services for the home instruction placement.

Teacher of record

An LEA must assign a teacher of record for each student with a disability. The teacher of record must be licensed or, where appropriate licensure is not available, be appropriately trained in the area of the student's primary disability.

Written notice of the results of an initial evaluation

No later than five days prior to an initial case conference committee meeting to determine the student's eligibility for special education and related services, the LEA must provide the parent with written notice that describes and provides the overall findings of each evaluation, procedure, assessment, record, and report the LEA used in the evaluation process and as the basis for any action the LEA may propose. The written notice must also include a description of the action the LEA may propose and an explanation of the reason the LEA may propose such action.

Opportunity to obtain a copy of the initial evaluation report and/or participate in a meeting to discuss the initial evaluation report prior to the case conference committee meeting to determine eligibility

A parent may request a copy of the initial evaluation report and/or a meeting to discuss the results of the initial evaluation up to five days prior to the case conference committee meeting at which the student's eligibility for special education and related services will be determined. Upon the parent's request, the LEA is required to provide the report, and an individual from the LEA who can explain the results of the evaluation is required to conduct a meeting with the parent, all prior to the scheduled case conference committee meeting.

Reevaluations

Reevaluations for the purpose of reestablishing a student's eligibility are limited to once a year unless the parent and LEA agree otherwise. However, there is no similar "once a year" restriction on reevaluations for the purpose of identifying a new or additional eligibility category or informing the case conference committee of the student's needs.

Additional option for parents when there is a disagreement about a proposed IEP

In addition to mediation and due process hearings, Article 7 provides that a parent may challenge a proposed IEP within ten instructional days of receipt of the proposed IEP by requesting and participating in a meeting with an LEA representative who has the authority to facilitate the disagreement between the parent and the LEA. The LEA is required to conduct this meeting upon the parent's request.

State Funding of extraordinary costs of educating students with a disability

To the extent that state funds are appropriated, IDOE is authorized under Indiana Code §20-35-6-2 to contract public or private entities to pay the costs of services that exceed the per capita cost of educating students of the same age and grade level in the student's LEA and the LEA's share of total tuition costs for students with disabilities. Article 7 prescribes the process by which an application for this funding is made and reviewed.

II. Where Article 7 provides clarification

Written notice after request for an initial evaluation

34 CFR §§300.304 and 300.503 require that notice be provided to parents within a "reasonable time" before the LEA proposes or refuses to initiate an evaluation of a student. Article 7 clarifies "reasonable

time” by requiring that the written notice of an initial evaluation be provided to parents within ten instructional days of receipt of the parent’s request for an evaluation.

34 CFR §300.530(e) requires the LEA, parent, and relevant members of the IEP team (as determined by the parent and the LEA) to conduct a manifestation determination. To avoid issues of disagreement between the parent and the LEA about which members of the case conference committee should participate in the manifestation determination Article 7 specifies that the case conference committee shall conduct the manifestation determination. The requisite members of the case conference committee are specified in Article 7.

Section V

A. Maintenance of State Financial Support

B. Significant Disproportionality
