Those who qualify can use their \$1,000 grant to access tutoring in English/language arts and math through approved Learning Partners statewide. Tutoring is also available in-person, online, or in a hybrid format, giving families flexible options to meet their students' needs. Enrollment is now open through Friday, December 19, and I encourage all families to check their eligibility and register today!
